**RE:** [Payment Rates](#) and [Income Guidelines](#) for the Period June 30, 2006, through June 29, 2007

Dear Women's Health Connection Program Provider:

The purpose of this correspondence is to announce the [Fee for Service Schedule](#) and the new [Income Guidelines](#) for the period June 30, 2006, through June 29, 2007, for the Women's Health Connection (WHC) Program. The new rates and guidelines are enclosed.

There are three major changes to the Fee for Service Schedule:

1. Separate rates have been established for each Office Visit code; and
2. The Centers for Disease Control and Prevention will only allow reimbursement of a 992xx code for the Preventive Medicine Evaluation codes of 99386, 99387, 99396, and 99397. Consequently, if the WHC Program receives a claim for any of the Preventive Medicine Evaluation codes, the code will convert to the corresponding office code, and will pay at that respective office visit rate. For example, the 99386 will convert to 99202 and will pay at \$66.70; the 99387 will convert to 99203 and will pay at \$99.24; the 99396 will convert to 99212 and will pay at \$39.66; and the 99397 will convert to 99213 and will pay at \$53.96.
3. Eight new codes have been added for Breast Cytology. They are 88104-TC; 88104-26; 88106; 88106-TC; 88106-26; 88107; 88107-TC; and 88107-26.

Please be aware that the rate changes will apply to all dates of service beginning June 30, 2006. Also, beginning on June 30, please use the new Income Guidelines to determine a woman's eligibility for the program.
