# THE NEVADA REGISTRATION SYSTEM

The Bureau of Health Planning and Statistics is the official government entity that collects, processes, analyzes, and maintains the State of Nevada's vital records. These responsibilities are delegated to the Office of Vital Records and the newly created Center for Health Data and Research within the Bureau, of which each section's primary responsibilities, as related to the State's vital records, are as follows:

The Office of Vital Records has two distinct components:

- The Vital Records Section where public requests for certified copies and amendments of said copies are processed.
- The Quality Control/Data Entry Section where the records are checked for completeness and accuracy and then entered into a database onto the State mainframe computer system.

The Center for Health Data and Research analyzes and publishes reports based on statistics from the vital statistics databases and also provides technical assistance to users of this data.

Births in all counties are recorded electronically, directly with the State Registrar; except in Clark and Washoe Counties, where they are initially processed and then transmitted to the State Registrar. Responsibility for the filing of the **birth certificate** lies with the hospital medical records or nursing personnel, the physician, midwife, or other attendant.

The vital events of deaths, marriages and divorces are first recorded at the county level before being forwarded to the State Registrar. Funeral Directors, or persons acting as such, are legally charged with filing **death certificates** and **fetal death certificates**. County Recorders are responsible for forwarding the original **marriage certificates**, or computerized tapes containing marriage data, to the Office of Vital Records for maintenance of a data file. The County Clerk of each county is required to submit a **report of decree of divorce/annulment** to the Office of Vital Records within a month of the occurrence.

Abortions are reported directly to the Office of Vital Records for encoding and entering into the State's database. **Induced abortion reports** are completed and sent in directly to the Office of Vital Records by the physician, hospital or clinic.

All records are checked for completeness and accuracy, and then given a State file number before they are encoded and entered into the State's database. Birth and death records are kept on permanent file for certification use and amendment when necessary by the public and various government agencies. Marriage, divorce, and abortion records are not maintained after entry into the State's database.

When a certificate is found to be inaccurate or incomplete, personnel follows up with the providing entity in accordance with NRS 440.150 to make the necessary corrections and/or improvements to make the record complete and satisfactory. So, it should be noted that the quality of data presented in this report is directly related to the completeness and accuracy of the information contained on the certificates.

This report summarizes data compiled from original birth, death, stillbirth and induced abortion, marriage and divorce records filed with the Office of Vital Records as discussed in NRS 440. Standard forms recommended by the National Center for Health Statistics are used for all records, with the exception of marriage and divorce.

# DEFINITIONS

- ABORTION:*** The termination of a human pregnancy with an intention other than to produce a live birth or to remove a dead fetus. (NRS 442.240)
- DEATH:*** A person who has sustained irreversible cessation of all functioning of the brain, including the brain stem, is considered dead. (National Center for Health Statistics (NCHS))
- DIVORCE:*** Legal termination of a marriage. (NCHS)
- FETAL DEATH:*** A birth that occurs after at least 20 weeks gestation in which the child shows no evidence of life after complete birth. (NRS 440.070)
- INFANT DEATH:*** Deaths occurring to individuals of less than one year of age. (NCHS)
- LIVE BIRTH:*** A birth in which the child shows evidence of life after complete birth. A birth is complete when the child is entirely outside the mother, even if the cord is uncut and the placenta is still attached. Evidence of life includes heart action, breathing, or coordinated movement of voluntary muscles. (NRS 440.030)
- LOW BIRTH WEIGHT:*** A birth wherein the birth weight is less than 2,500 grams (5 lbs 8 oz). (NCHS)
- MARRIAGE:*** A formal mutual relation of husband and wife that is filed with the County Recorder in the county where the license was issued. (NCHS)
- NEONATAL DEATH:*** Death occurring to infants in the first 27 days of life. (NCHS)

***OCCURRENCE  
(COUNTY OF):***

Data allocated by the location of where the event actually occurred. (NCHS)

***PERINATAL DEATH:*** Death occurring to a fetus of 20 weeks gestation or more, including infant deaths occurring within 27 days of life. (NCHS)

***PRENATAL CARE:*** The care received by the mother from a health professional or midwife during the length of the pregnancy. (NCHS)

***POST-NEONATAL  
DEATH:***

Death occurring to infants less than one year of age, but older than 27 days. (NCHS)

***RESIDENCE  
(COUNTY OF):***

The usual residence of the individual. For deaths, this is defined as the usual residence of decedent as indicated on the certificate. For births and fetal deaths, the residence is defined as the usual place of residence of the mother. (NCHS)

***S.I.D.S.:***

Death due to Sudden Infant Death Syndrome. (NCHS)

***TEEN PREGNANCY:*** The number of live births, abortions and fetal deaths to women 19 years old and younger. (NCHS)

***UNDERLYING CAUSE  
OF DEATH:***

The disease or condition which gave rise to the chain of morbid events leading to death, including the circumstances of an accident or violent event that produced a fatal injury. (NCHS)

***VERY LOW  
BIRTH WEIGHT:***

A birth wherein the birth weight is less than 1,500 grams (3 lbs 4 oz). (NCHS)

# TECHNICAL NOTES

## ***ABORTION DATA:***

*Year 2000 abortion data will not be available in this edition, but will be available in the 2001 edition of the Nevada Vital Statistics Report.*

## ***RACE AND ETHNICITY:***

In conjunction with the US Bureau of the Census and the National Center for Health Statistics definition, Hispanics are an ethnic group, not a race, and may include all races within their ethnic classification. In this report, Asian-Pacific Islander, Black, Native-American, and White exclude Hispanics; therefore, no duplicate counting exists. However, when National data are used for comparison, methodologies may differ by including Hispanic and Non-Hispanic populations within separate racial groups, as well as including different racial groups within the Hispanic ethnic group.

## ***POPULATION DATA:***

The Nevada population data used in this report are based on the database established by the Nevada State Demographer's Office and the Nevada Department of Taxations, as well as 1990 and 2000 Census data from the US Bureau of the Census. Due to these changes in methodology, rates for subgroups published in this edition may not match or be directly comparable to past years, and should be used with caution when compared to other published rates.

## ***COUNTY COMPARISONS:***

The population size of the counties in Nevada is widely varied, from one thousand to over one million. Because of these differences, caution should be used when interpreting rate comparisons for counties in Nevada.

## ***REGIONAL COMPARISONS:***

Approximately eighty-six percent (86%) of Nevada's population resides in the urban areas of Clark (Greater Las Vegas area) and Washoe (Greater Reno/Sparks area) Counties. In this report, data are frequently stratified into three regions within the State as follows: Clark County, Washoe County, and All Other Counties (all remaining 15 counties).

### ***AGE ADJUSTMENT METHODS AND STATISTICAL ANALYSIS OF MORTALITY RATES:***

In order to make meaningful comparisons between mortality rates for residents from different regions or different racial/ethnic groups, differences in the age characteristics of each population should be taken into account. For example, one would expect that the mortality rate for heart disease would be high in a population that has a high proportion of older individuals.

Age-adjustment is the application of the age-specific rates in a population of interest to a standardized age distribution in order to eliminate the differences in observed rates that result from age differences in the populations being compared. This adjustment is usually done when comparing two or more populations at one point in time or one population at two or more points in time.

In this report, the death rates are age-adjusted to the 2000 US Standard distribution population (relative age distribution of the 2000 enumerated population of the United States totaling 1,000,000). This method produces the rate that would be expected if the population of interest had the same population age distribution as the standard population.

Adjusted rates were calculated in the following manner:

- The expected number of deaths in each age group was determined by multiplying the age-specific rates ( $N_i/P_i$ ) by the corresponding age-specific standard population total ( $S_i$ ).
- Age adjusted rates (AAR) per 100,000 population were calculated by dividing the expected total number of deaths ( $E_i$ ) by the total standard population and multiplying by 100,000.

#### **Note:**

The 2000 data used in this report represents the first year in which rates, age-adjusted to the 2000 US Standard population relative age distributions for the year 2000 enumerated population of the United States, have been utilized not in conjunction with the 1940 standard population distribution. The reason for this is that the National Center for Health Statistics requires rates, beginning with 1999 data, to be age-adjusted to the 2000 US Standard population relative age distribution. This change was initiated to allow rate comparisons between populations with differing age characteristics while more accurately reflecting the current age distributions within the National population.

*Since 1990, although the numbers of Births, Deaths and Divorces increased, Nevada has experienced a decrease in the rate of each of these events that occur every year. Nevada's Birth Rate decreased nearly 15% from 17.3 (per 1,000 population) in 1990 to 14.8 in 2000. Nevada's Crude Death Rate decreased 1% from 738.8 (per 100,000 population) in 1990 to 730.8 in 2000. However, once age-adjusted comparisons were made, the Age-adjusted Mortality Rate for Nevada decreased 9.8% from 1990 (976.9) to 2000 (881.5 per 100,000 – 2000 US Standard population). While the Divorce Rate also experienced a significant decline of 31% from 1990 (10.6) to 2000 (7.3 per 1,000 population), Nevada remains among the highest in the nation for Divorce Rates. This standing may reflect Nevada's relatively lenient state laws, combined with the State's small population base, resulting in disproportionately high rates.*

*Only six of the top fifteen names for male babies in 2000 were in the top fifteen for 1980. Michael and Christopher fell from first and second to sixth and seventh, respectively, while Anthony moved up to first from sixteenth in 1980. The only three female baby names that were also in the 1980 top fifteen were Jennifer, Jessica and Sarah, which were ranked first, third and fifth, respectively in 1980.*

Figure 1. On an Average Day in Nevada in the Year 2000 ...

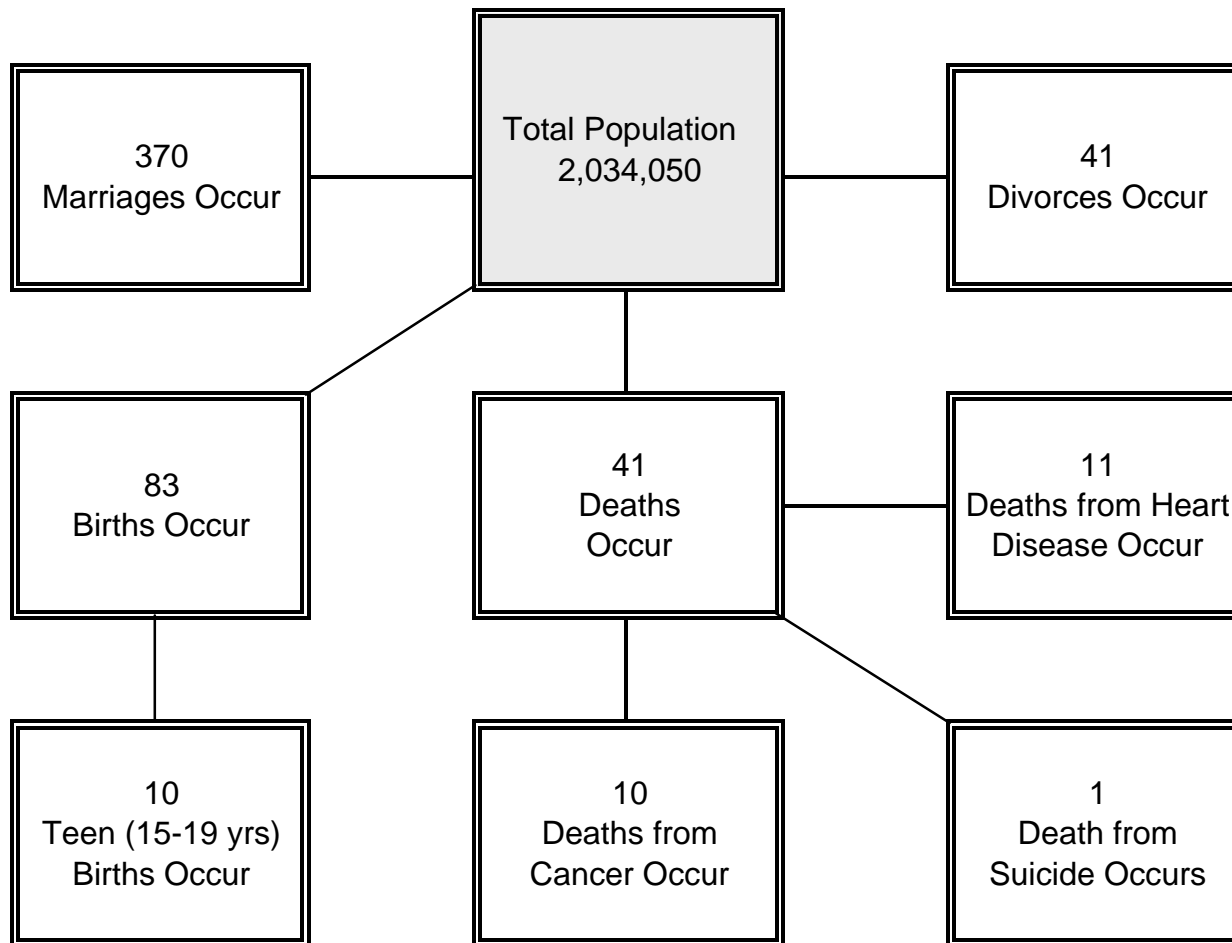

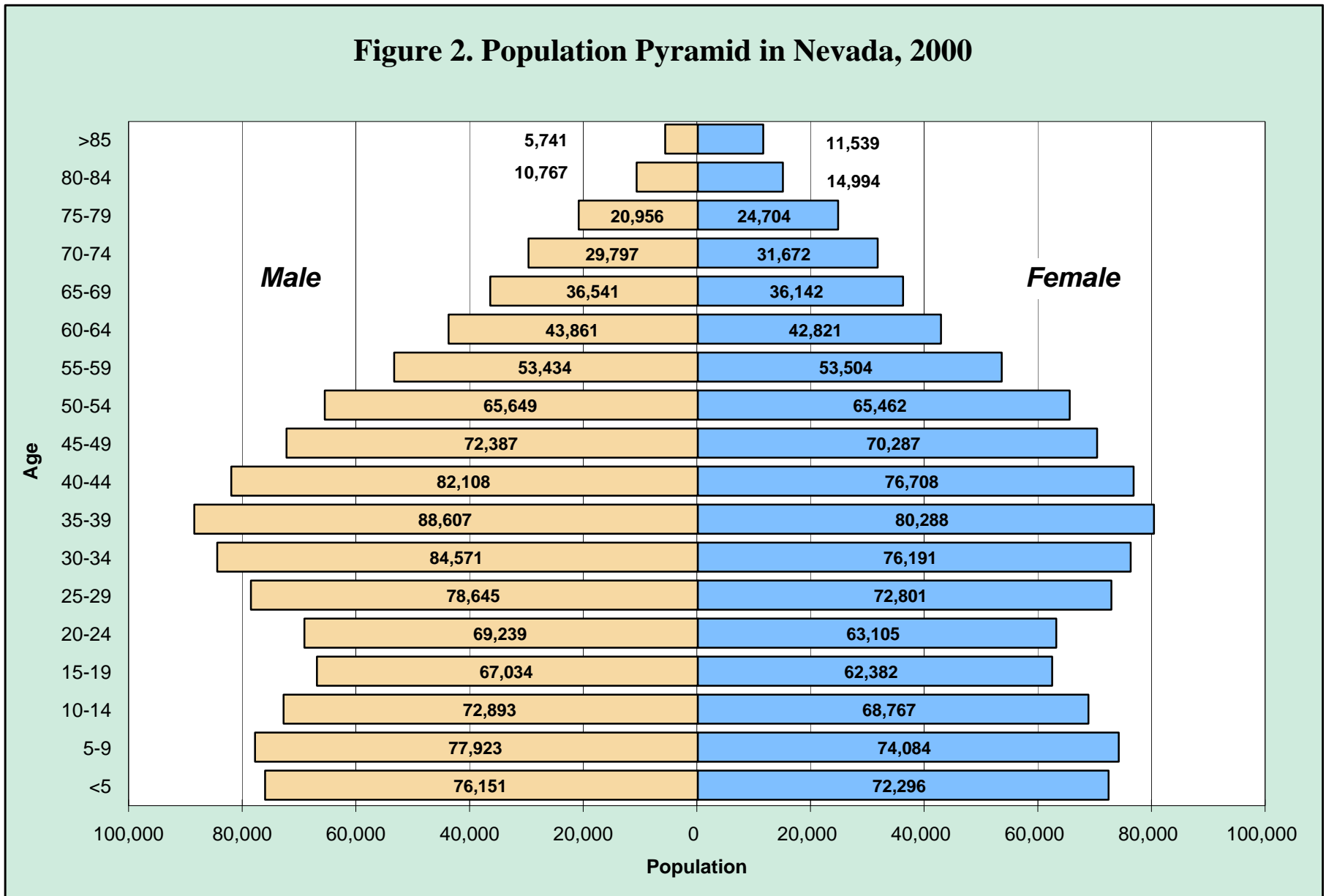
*From 1990 to 2000, Nevada was by far the fastest growing state in the nation; and Las Vegas was the fastest growing metropolitan area in both Nevada and the nation. The 1990 Nevada population of 1,236,130 grew by over 64% to 2,034,050 in 2000 and is projected to surpass 2,750,000 by 2005. The vast majority of growth has been by in-migration. The Las Vegas and Reno metropolitan areas contain more than four out of every five (86%) of the state's residents.*

*The age distribution of Nevada's population varies from the nation as a whole by having a higher share of people in the age groups of 9 and under and between 25 and 74; while having a lower share of those 10 to 24 and those 75 and older. However, as an age group, the 75 and older population experienced the greatest change since 1990 with a statewide increase of 108%. This increase was focused in Clark County (130%), followed by All Other Counties, as a region, and Washoe County with increases of 84% and 71%, respectively.*

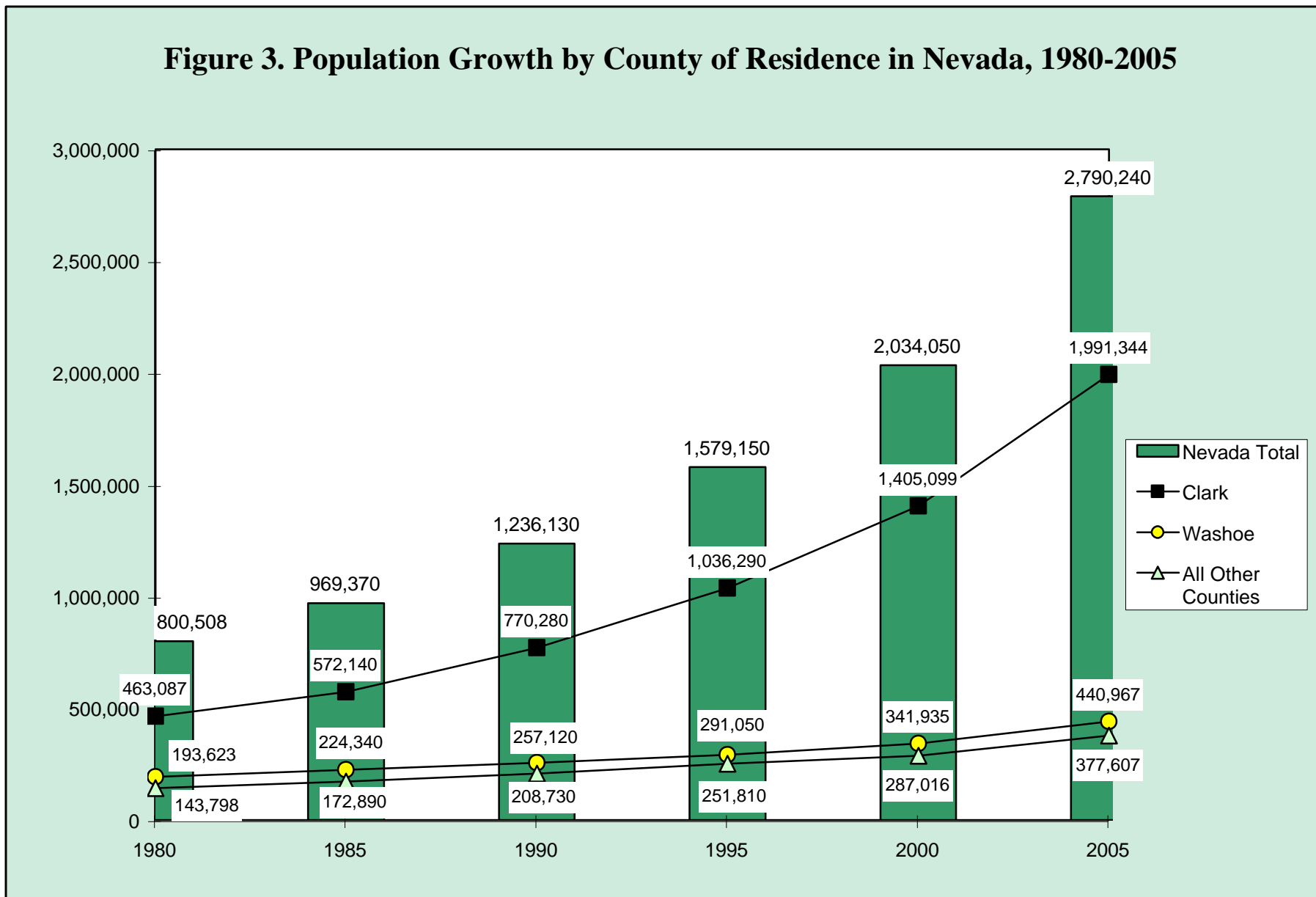
*In 2000, 66.8% of Nevada's population was White-Non Hispanic. Hispanic, Black-Non Hispanic, Asian-Non Hispanic, and Native American-Non Hispanic consisted of 20.4%, 6.8%, 5.0%, and 1.1% respectively. Since 1990, the fastest growing ethnic groups in the state were of Hispanic and Asian origin, with increases of 233.0% and 180.5% respectively. Although their growth has been relatively slower than Hispanic or Asian groups; Blacks, Whites and Native Americans have still increased 80.5%, 43.4% and 27.1% respectively, since 1990.*

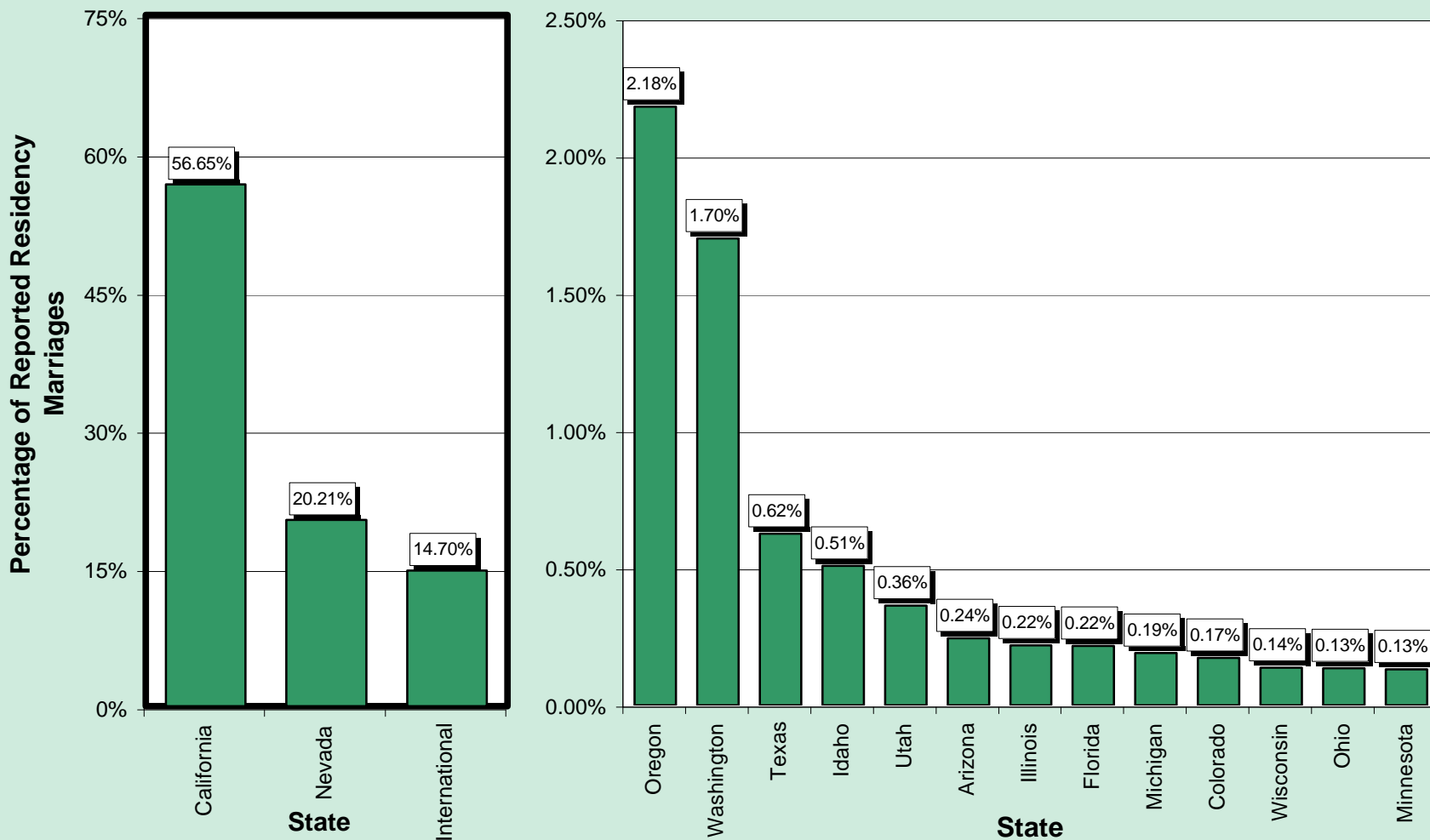

*In 2000, 134,908 marriages were filed in Nevada. For those brides and grooms who reported their residency, the leading resident places were California (57%), Nevada (20%), and International Countries (15%), followed by border states, e.g. Oregon, Washington, Idaho, Utah, and Arizona; and by states with large populations, e.g. Texas, Illinois, and Florida. More than 97% of marriages occurred in three heavy tourism oriented counties: Clark (79%), Washoe (14%), and Douglas (4%).*

*Divorces are only granted to Nevada residents who have resided in the state at least 6 weeks. In 2000, there were 14,804 divorces filed in Nevada and the divorce rate was 7.3 per 1,000 population, more than twice the national average (US preliminary 2000 = 3.4/1,000). Historically, Nevada's divorce rates have consistently been the highest in the nation, which may reflect relatively lenient state laws, combined with Nevada's small population base, resulting in disproportionately high rates. The counties with the highest divorce rates in Nevada were Churchill (23.8/1,000), Douglas (13.0/1,000), Carson City (7.7/1,000), Clark (7.3/1,000), and Washoe (7.1/1,000), again heavy tourism oriented counties.*

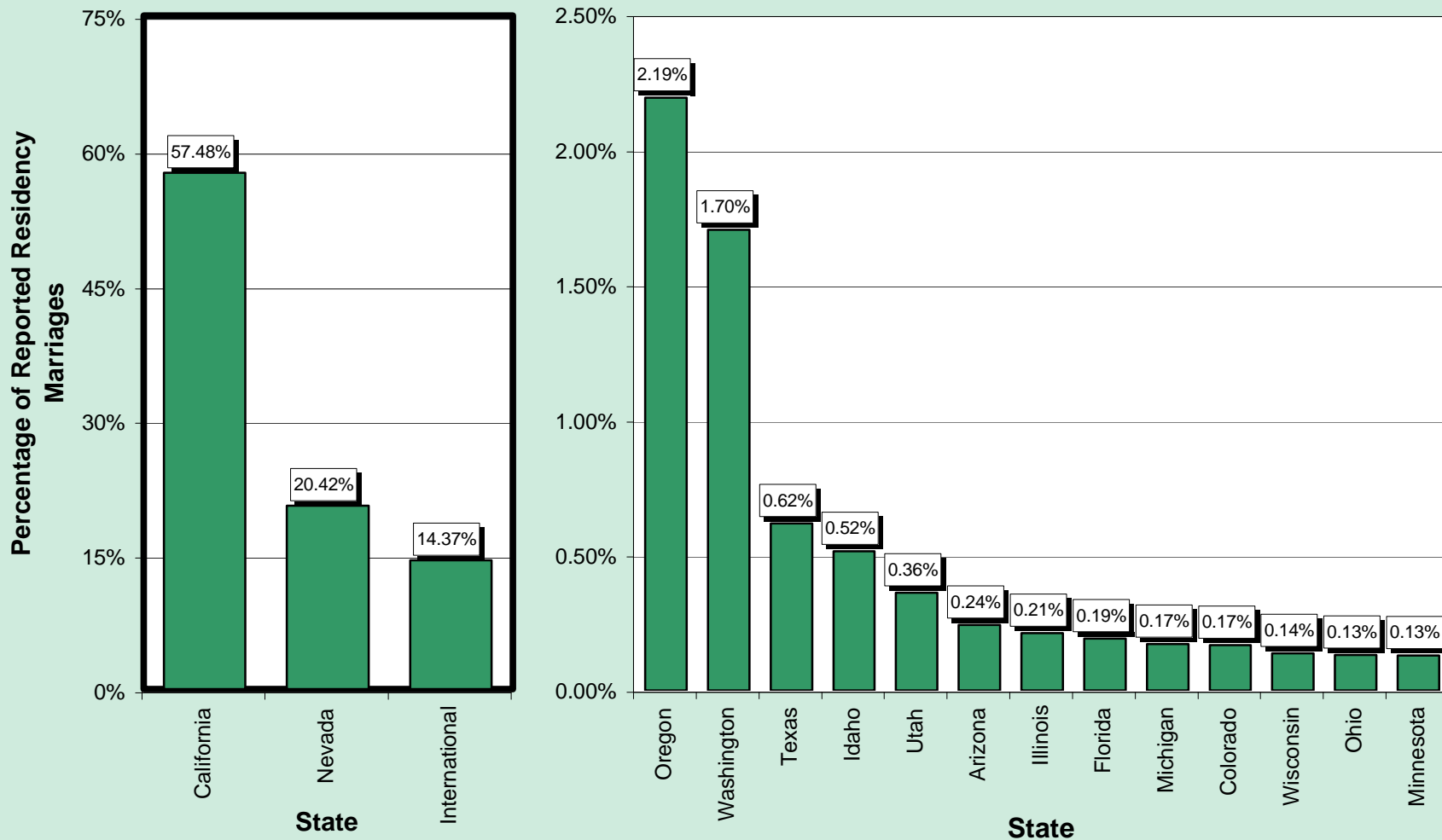

**Figure 4. Percentage of Nevada Marriages by Groom's State of Residence\*, Nevada 2000**



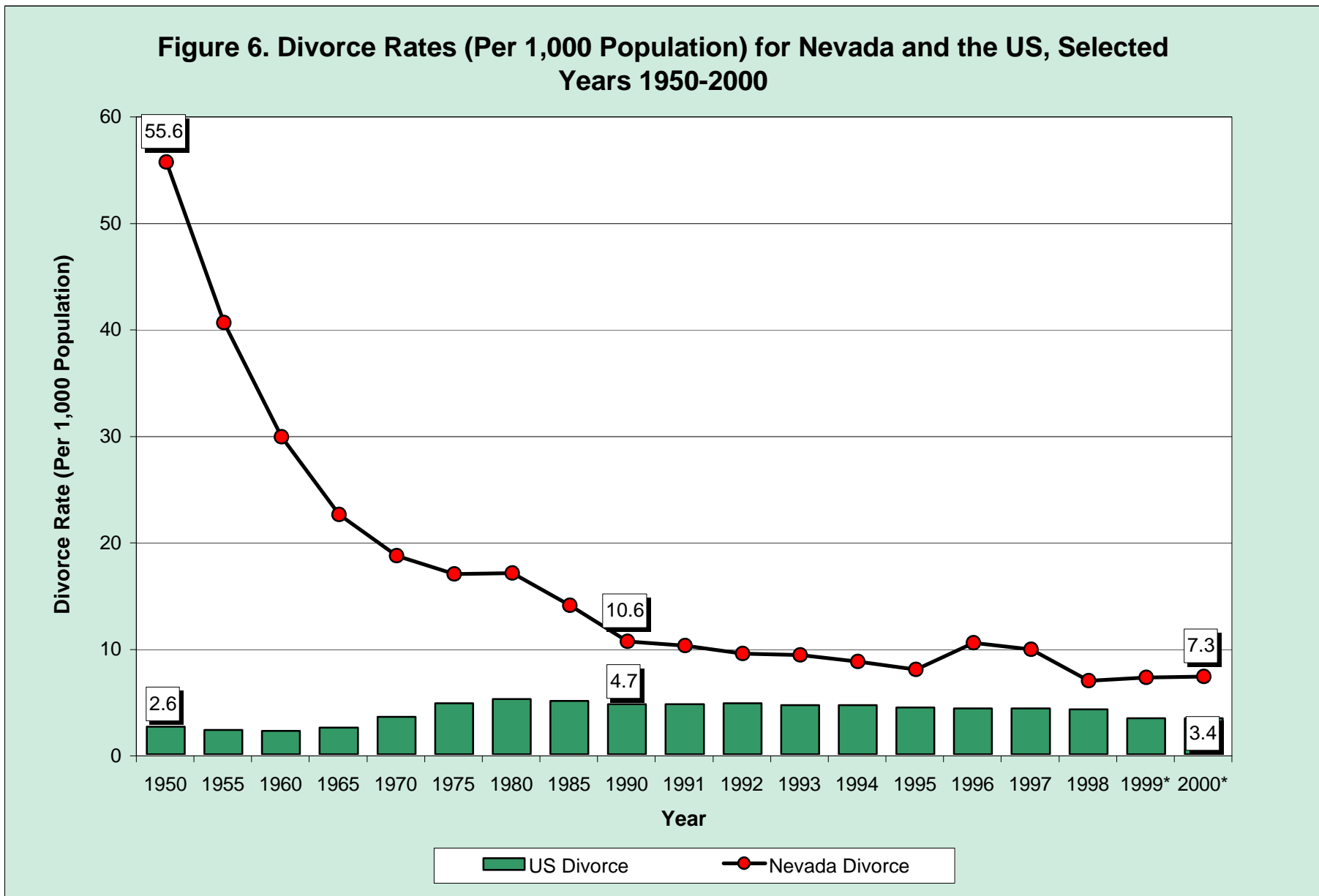

**Figure 5. Percentage of Nevada Marriages by Bride's State of Residence\*, Nevada 2000**

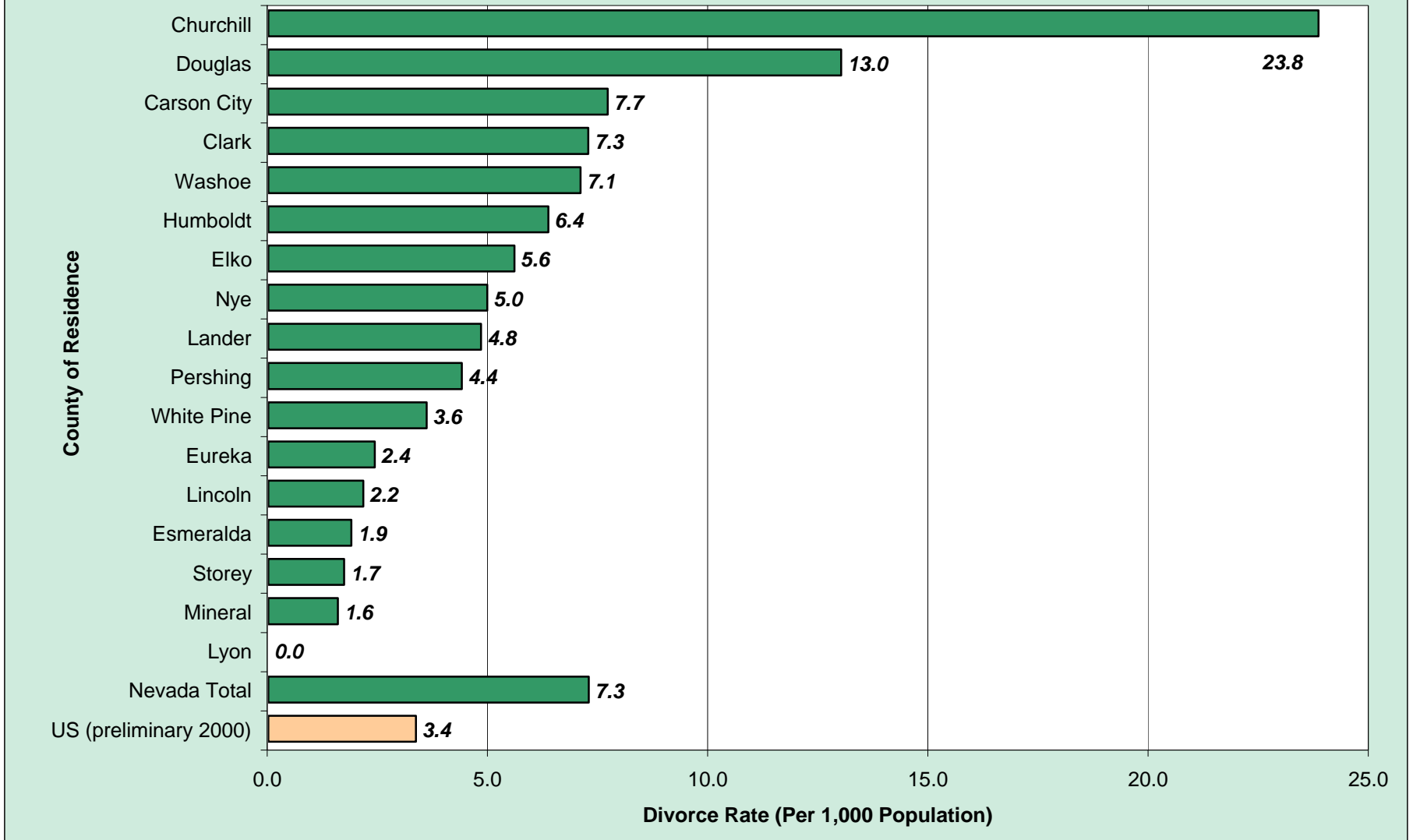

*Nevada experienced an increasing birth rate from 1985 to 1990, followed by a general decrease in the rate through 1999. The birth rate then slightly increased from 14.7 (per 1,000 population) in 1999 to 14.8 (per 1,000 population) in 2000. There were a total of 30,477 live births in Nevada in 2000; among them, 30,130 were with the mother's residency in Nevada.*

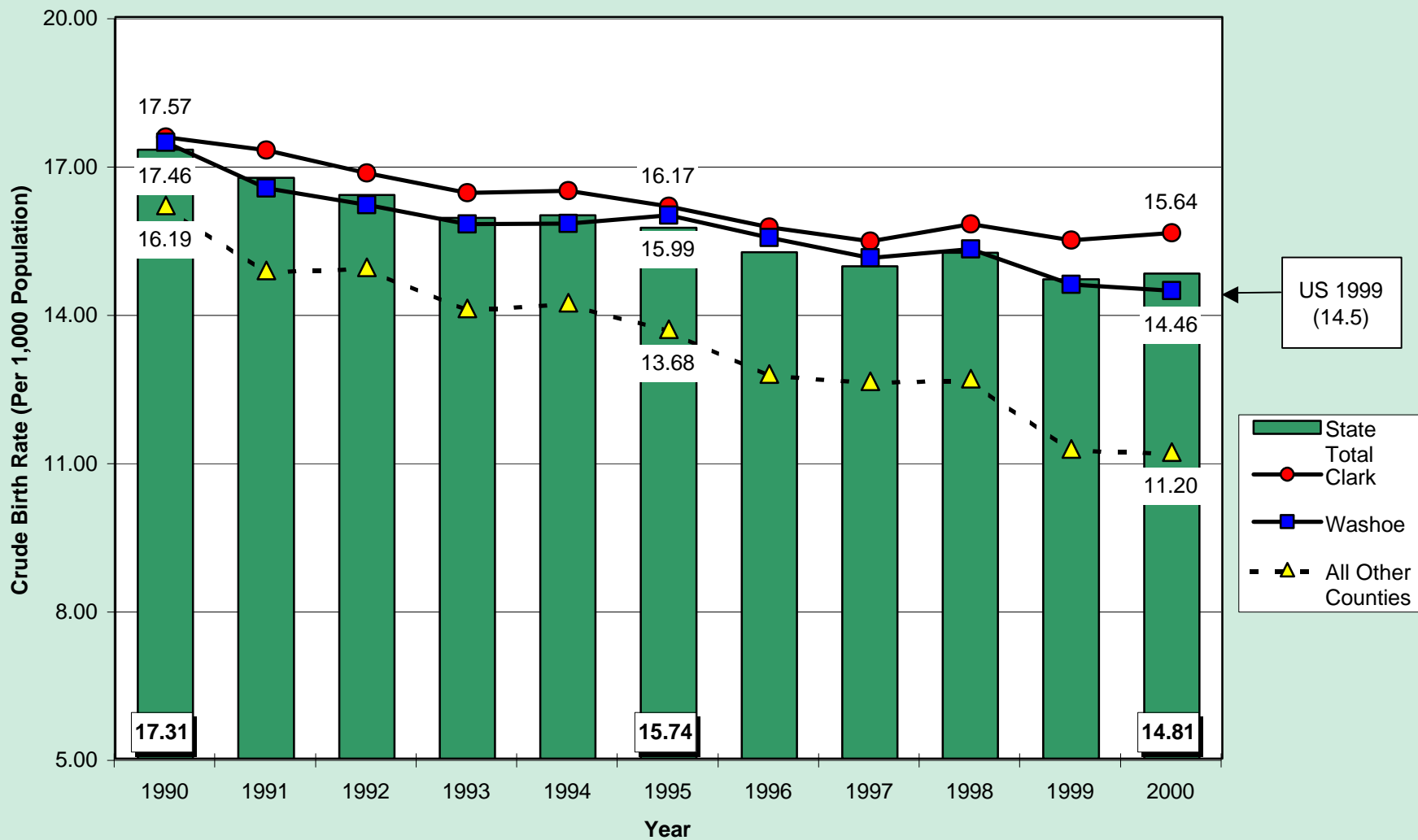
*While the birth rates in Clark, Washoe, and All Other Counties decreased from 1990 to 2000, the distribution of births in Nevada moved significantly towards Clark County Residents. In 1990, 63.2% of total births were to Clark County Residents, while in 2000, Clark County residents accounted for 72.9% of total births; a 9.6% increase. Washoe Counties and All Other Counties, as a whole, declined 4.6% and 5.1%, respectively during this same period. The highest crude birth rates for individual counties in 2000 were Lander, Humboldt and Clark County with rates of 16.4, 16.2 and 15.6, respectively.*

*The crude birth rate for Whites was the lowest among all other racial/ethnic groups in Nevada with 11.4 (per 1,000 population) in 2000. The Hispanic ethnic group had a crude birth rate of 24.4 per 1,000 population, followed by Asians, Native Americans, and Blacks with 19.0, 16.9 and 16.5, respectively.*

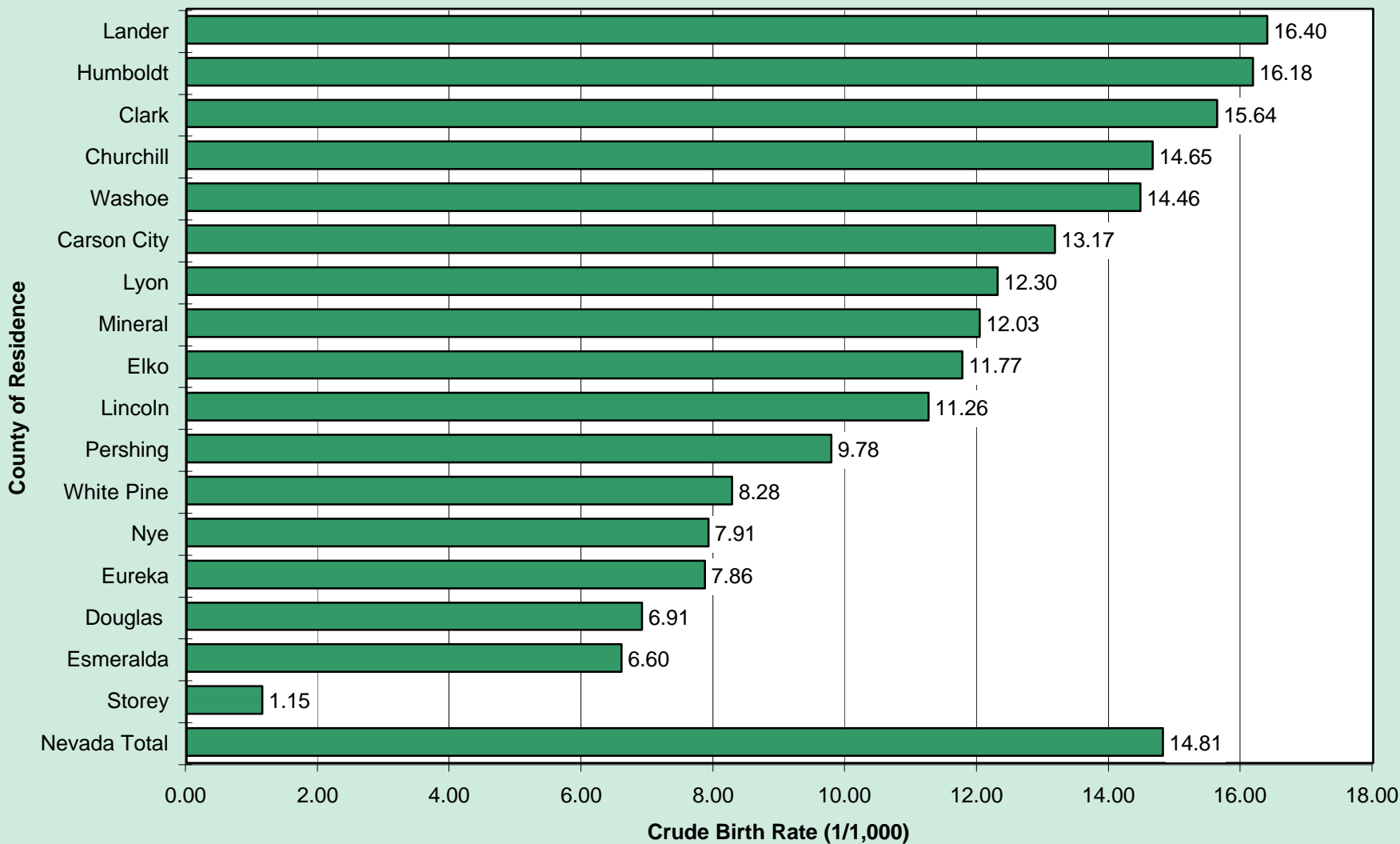

Nevada Residents, 2000**

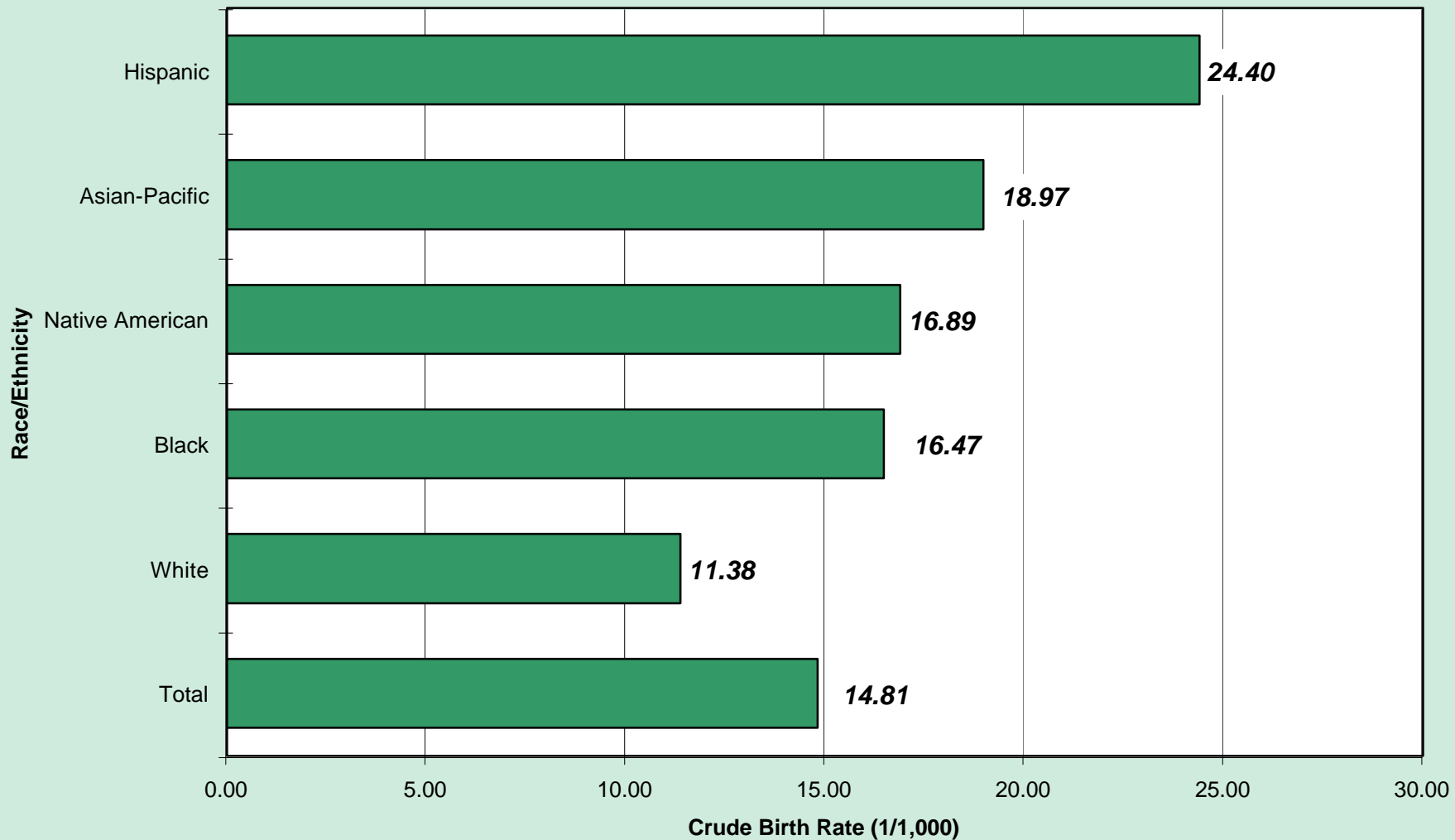
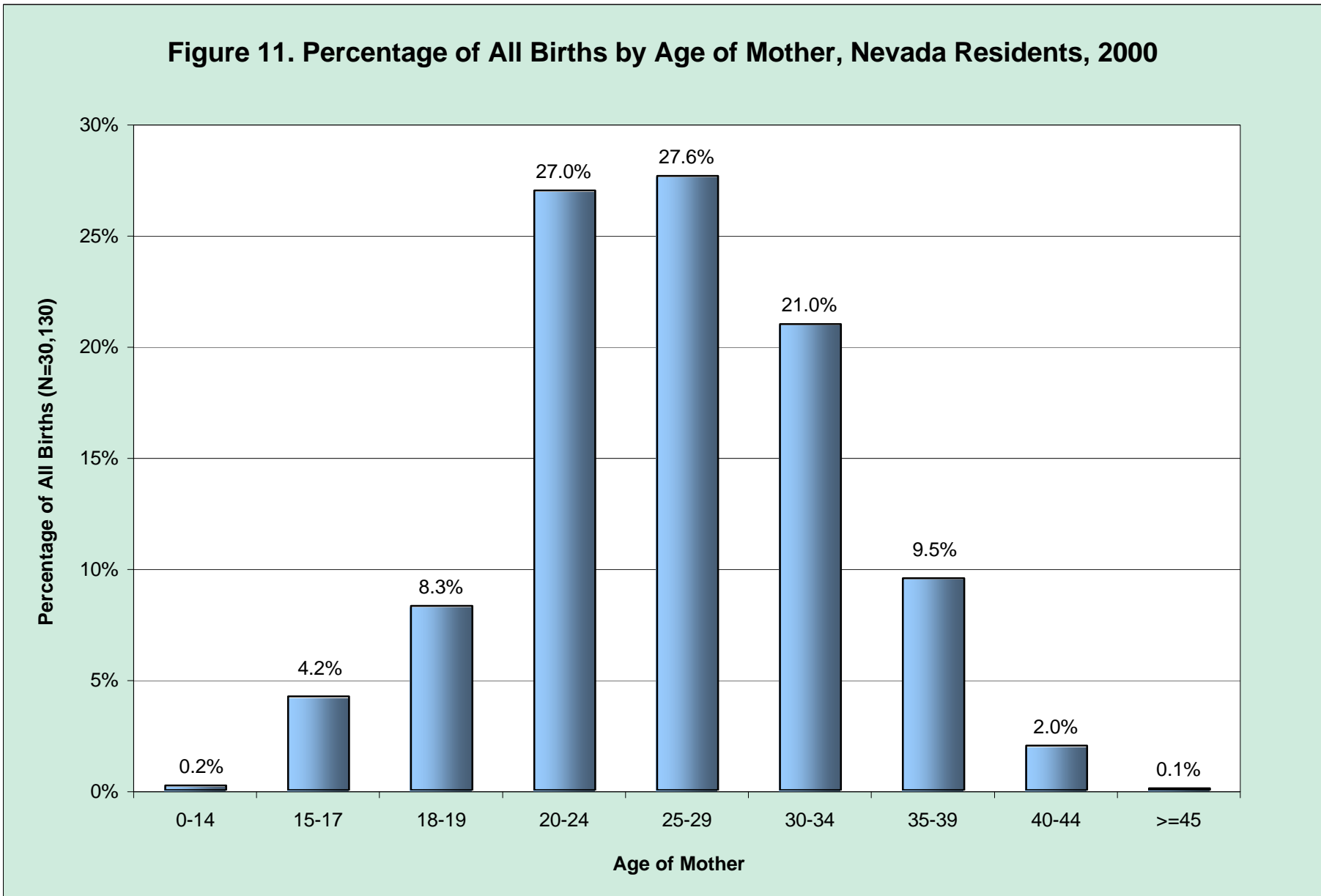


Figure 11. Percentage of All Births by Age of Mother, Nevada Residents, 2000

*The rate of prenatal care in the first trimester decreased 3% from 77.3% in 1999 to 74.3% in 2000, which is the lowest rate in five years for Nevada. In 2000, among the racial/ethnic groups, Whites had the highest prenatal care rate at 84.3%; followed by Asians, Blacks, Native Americans, and Hispanics with rates of 79.2%, 65.2%, 63.6%, and 60.2%, respectively.*

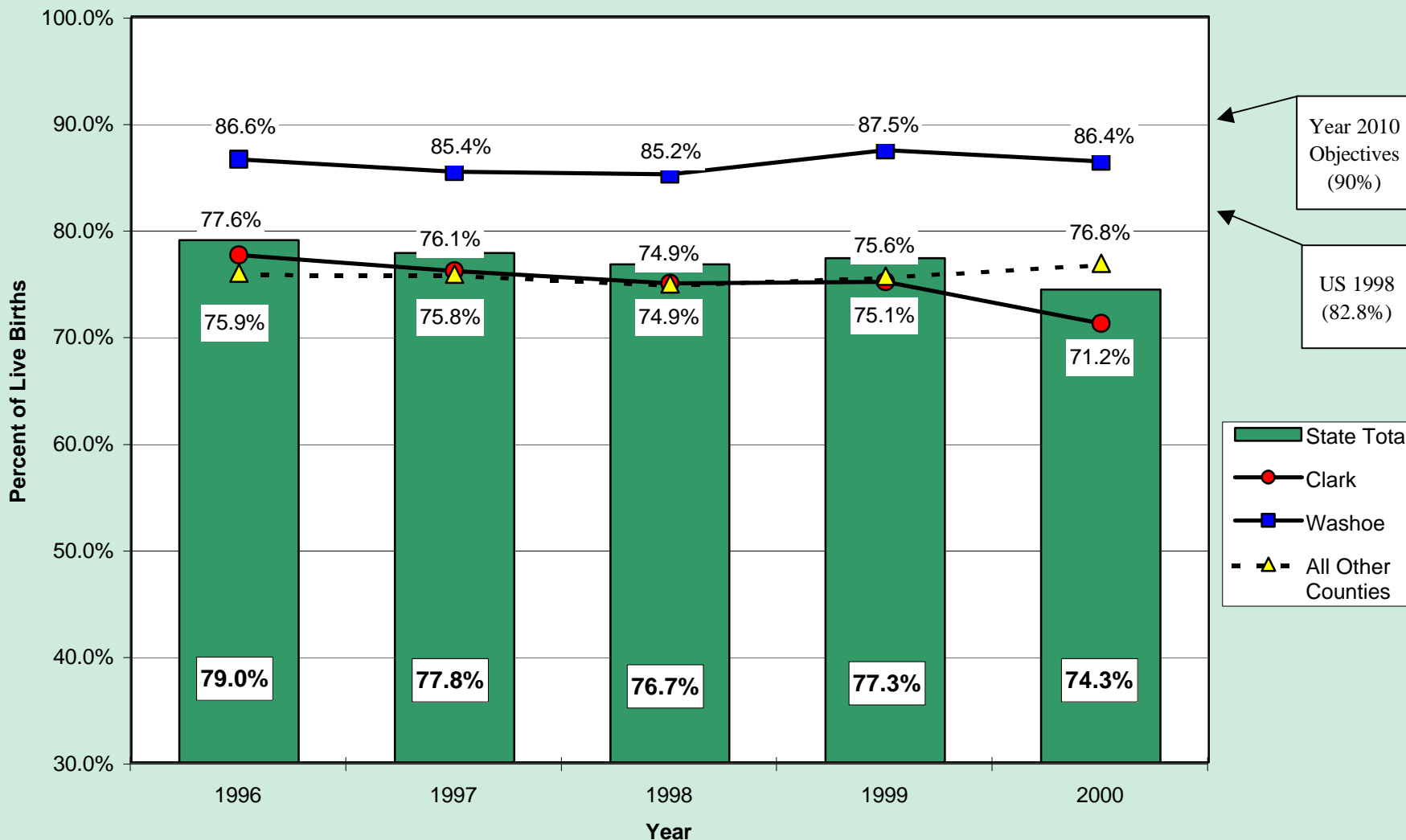
*The incidence of low birthweight babies in Nevada decreased to 7.2% in 2000 from 7.6% in 1999. Although the rate of Blacks improved from 14.1% in 1997 to 12.8% in 1999, the rate experienced a small increase to 12.9% in 2000, which still made them the racial/ethnic group with the highest low birth weight rate in Nevada for 2000.*

*Nevada's teen birth rate continued the general decreasing trend of the past six years for all teen age groups. The birth rate for females ages 15-19 decreased 12% from 1994's 68.7 per 1,000 female age-specific population to 60.4 in 2000.*

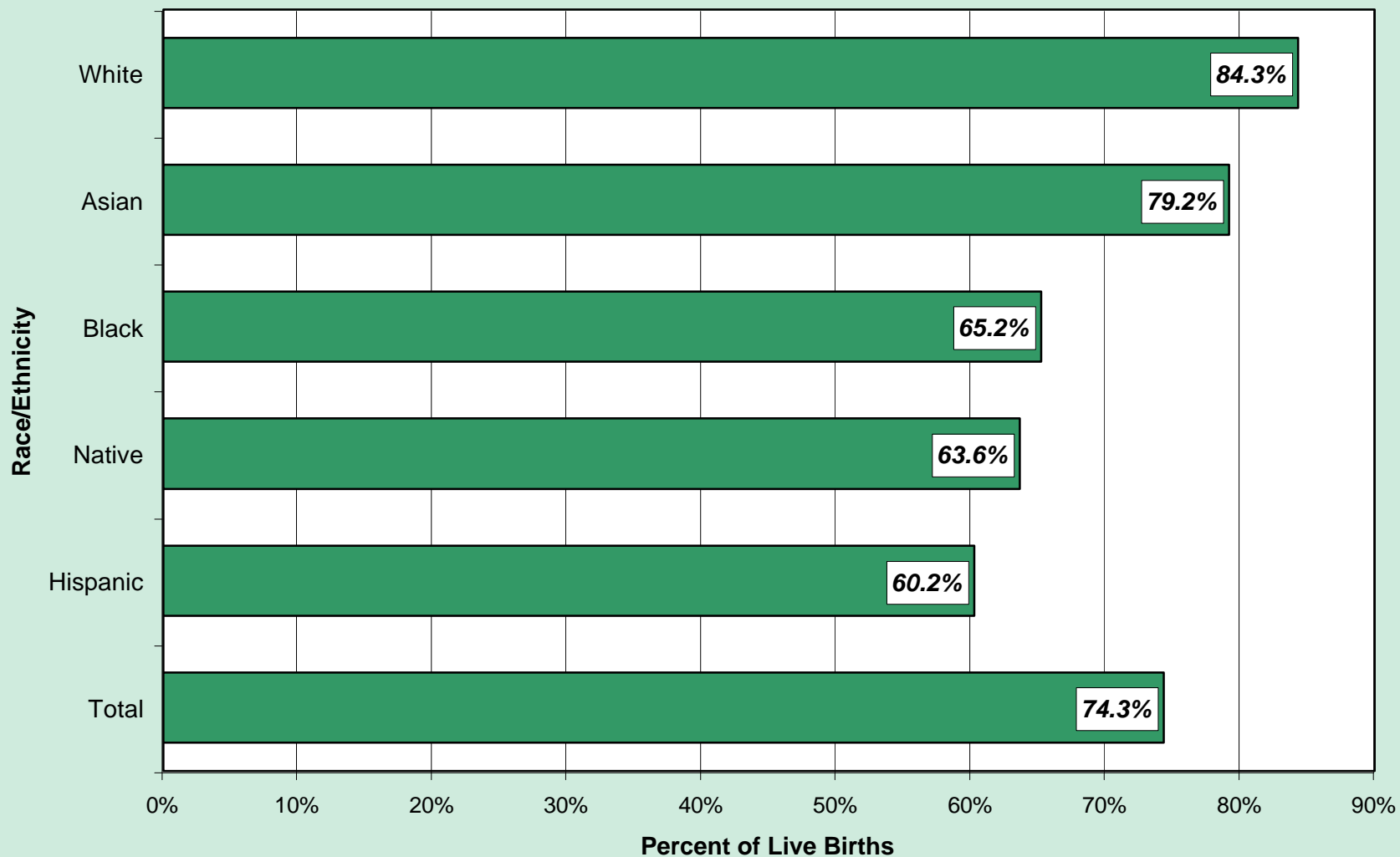

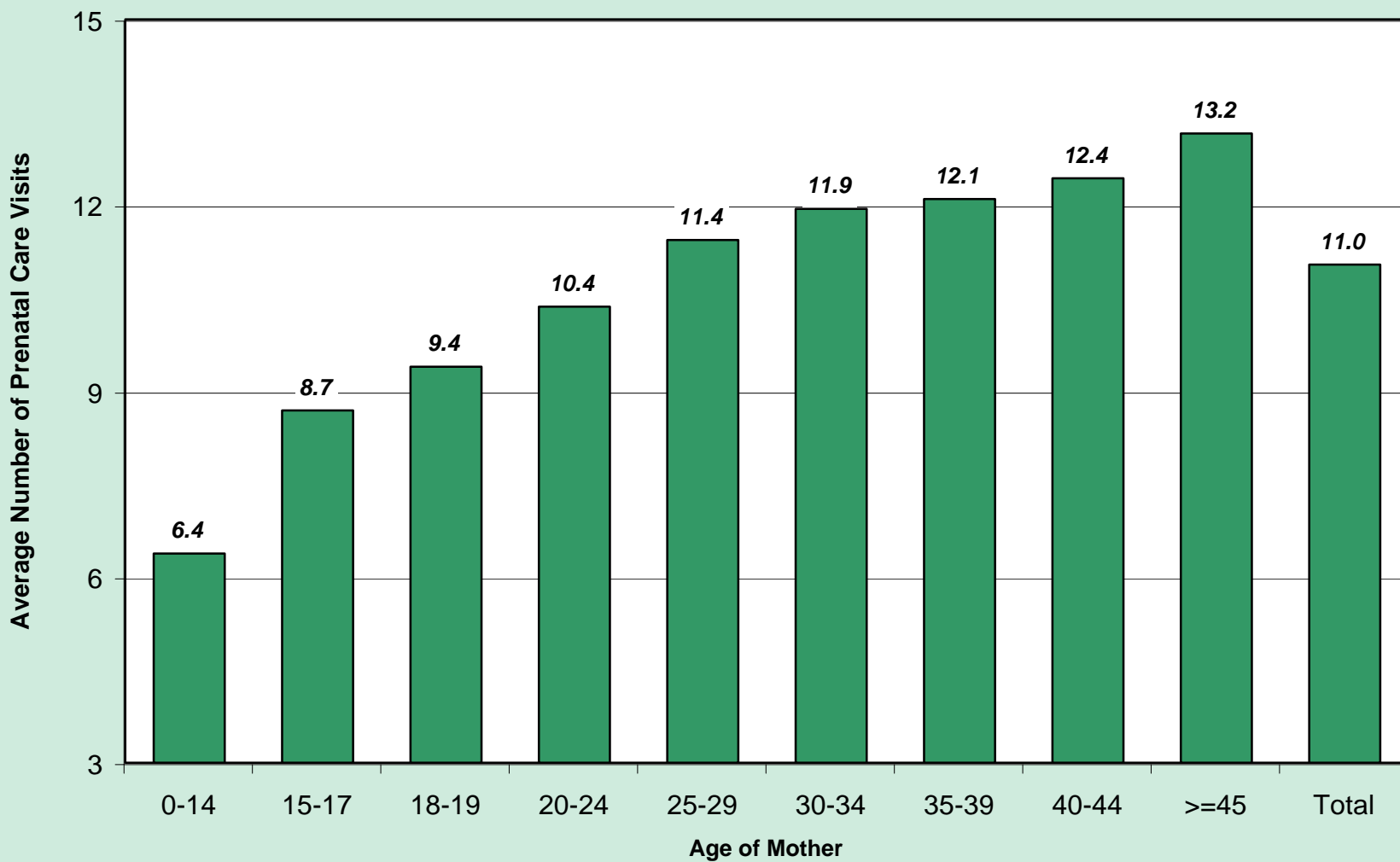
**Figure 12. Percentage of Mothers Receiving Prenatal Care in the First Trimester, Nevada Residents, 1996-2000**



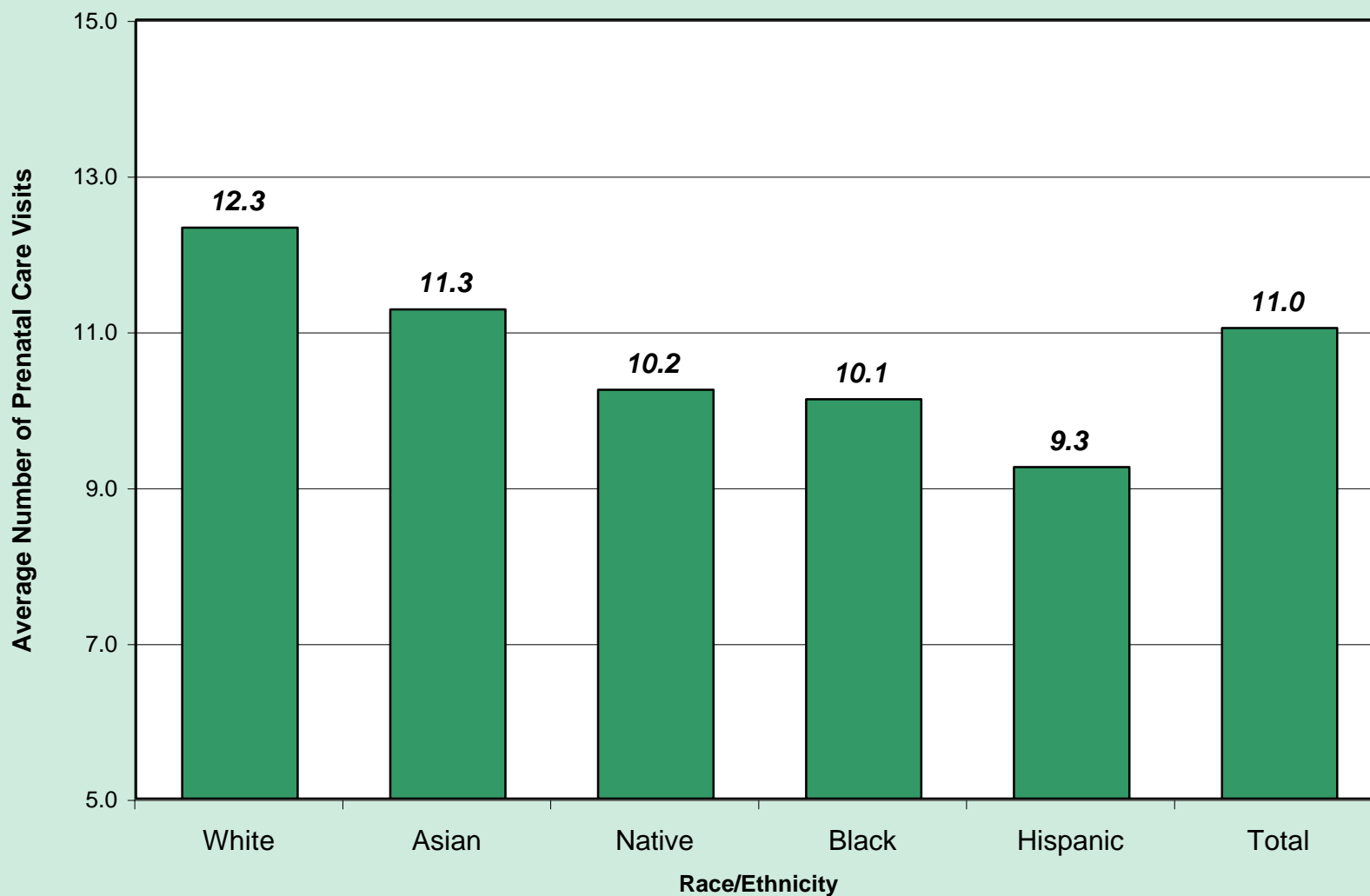
**Figure 13. Percentage of Mothers Receiving Prenatal Care in the First Trimester by Race/Ethnicity, Nevada Residents, 2000**



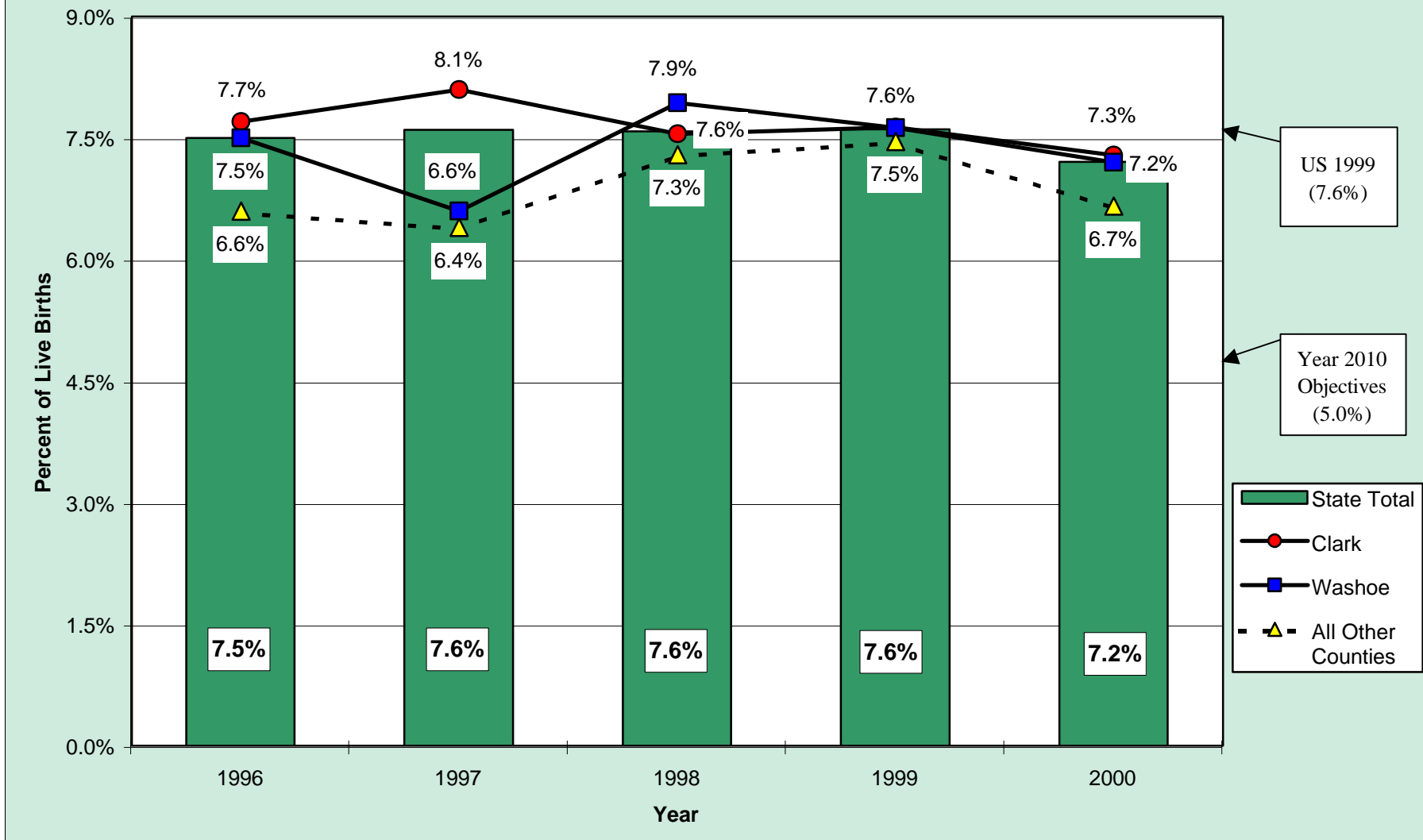
**Figure 14. Average Number of Prenatal Care Visits by Age of Mother, Nevada Residents, 2000**



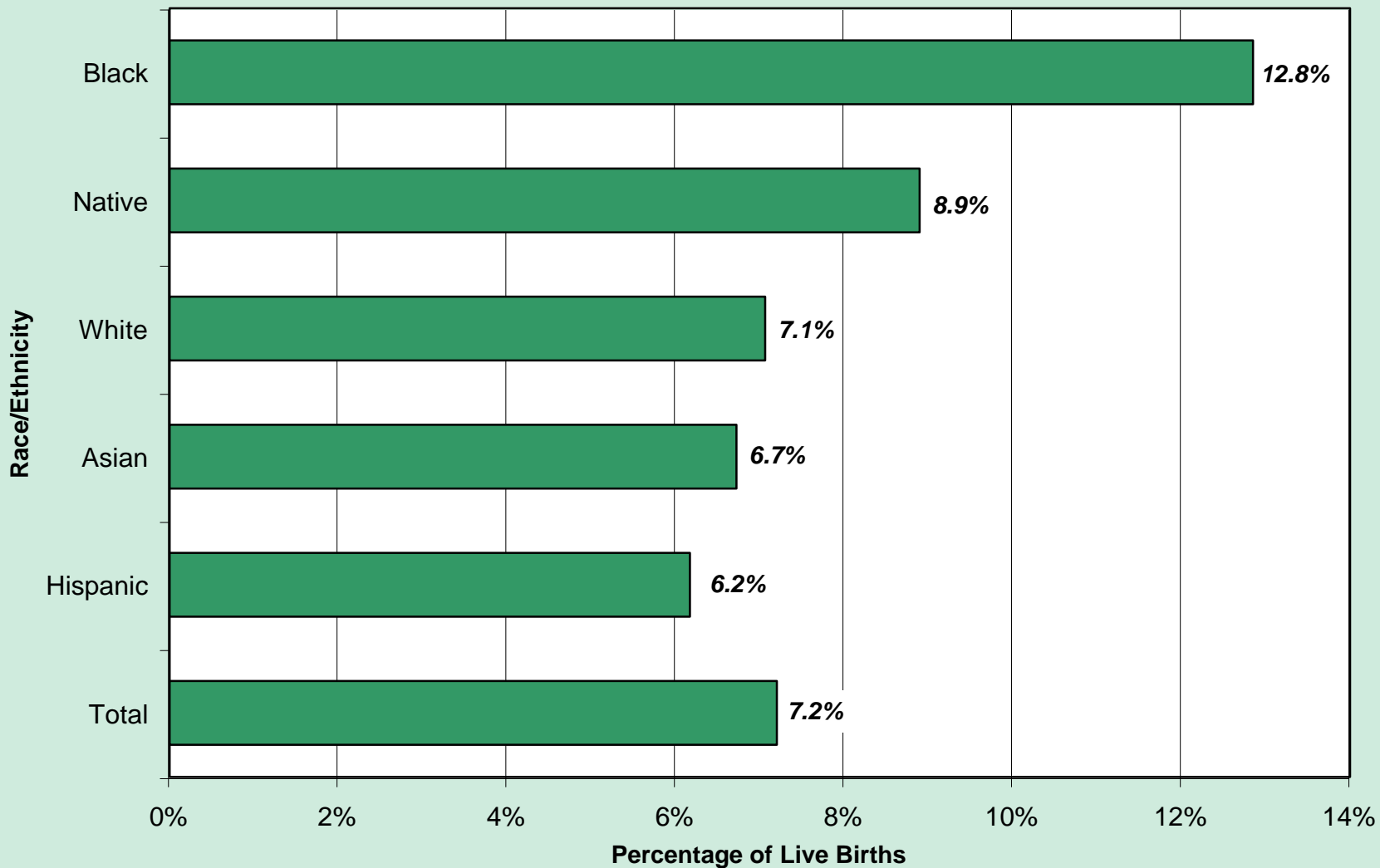
**Figure 15. Average Number of Prenatal Care Visits by Race/Ethnicity of Mother, Nevada Residents, 2000**



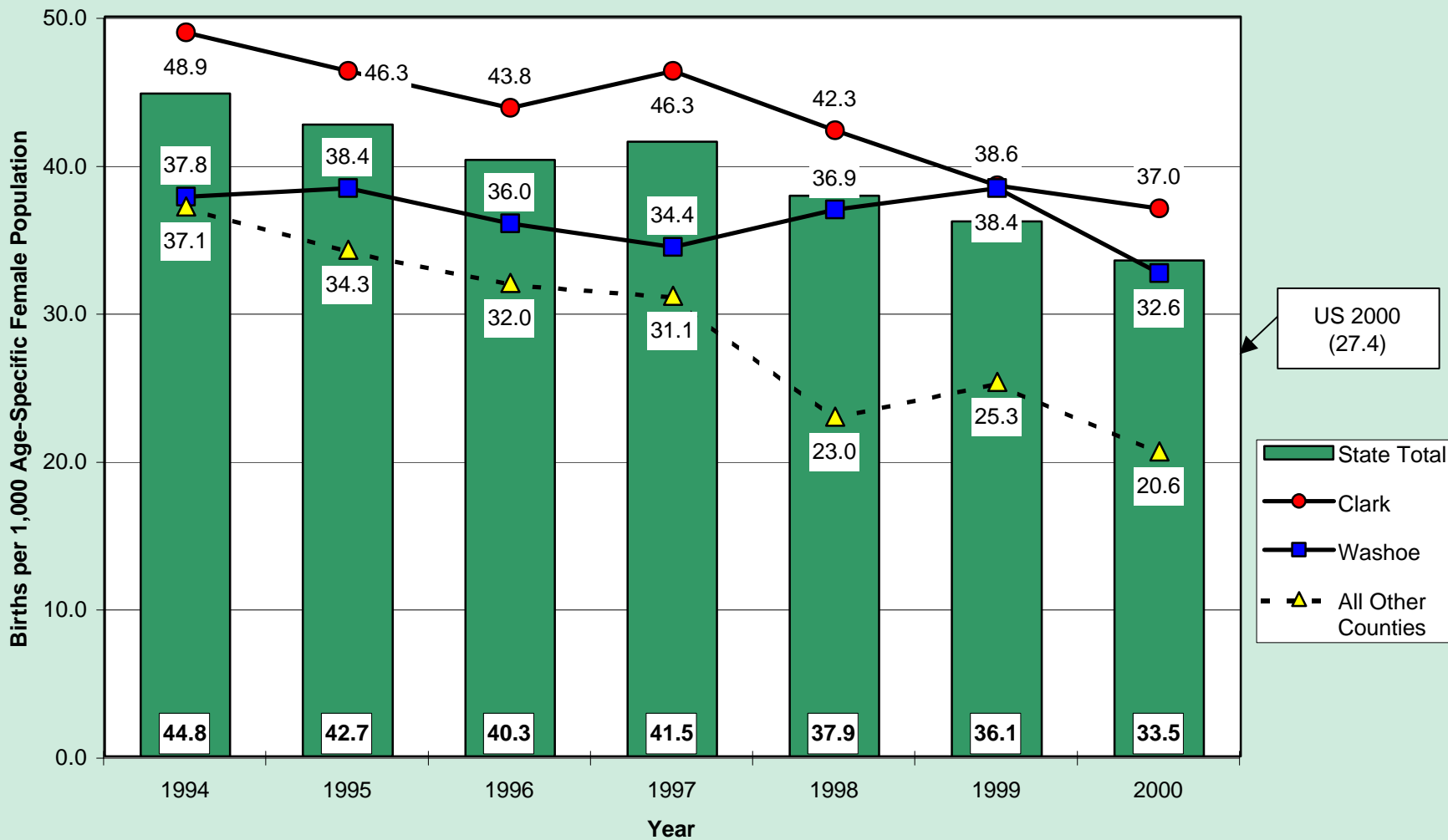
**Figure 16. Low Birth weight (<2,500 g) Rates, Nevada Residents, 1996-2000**



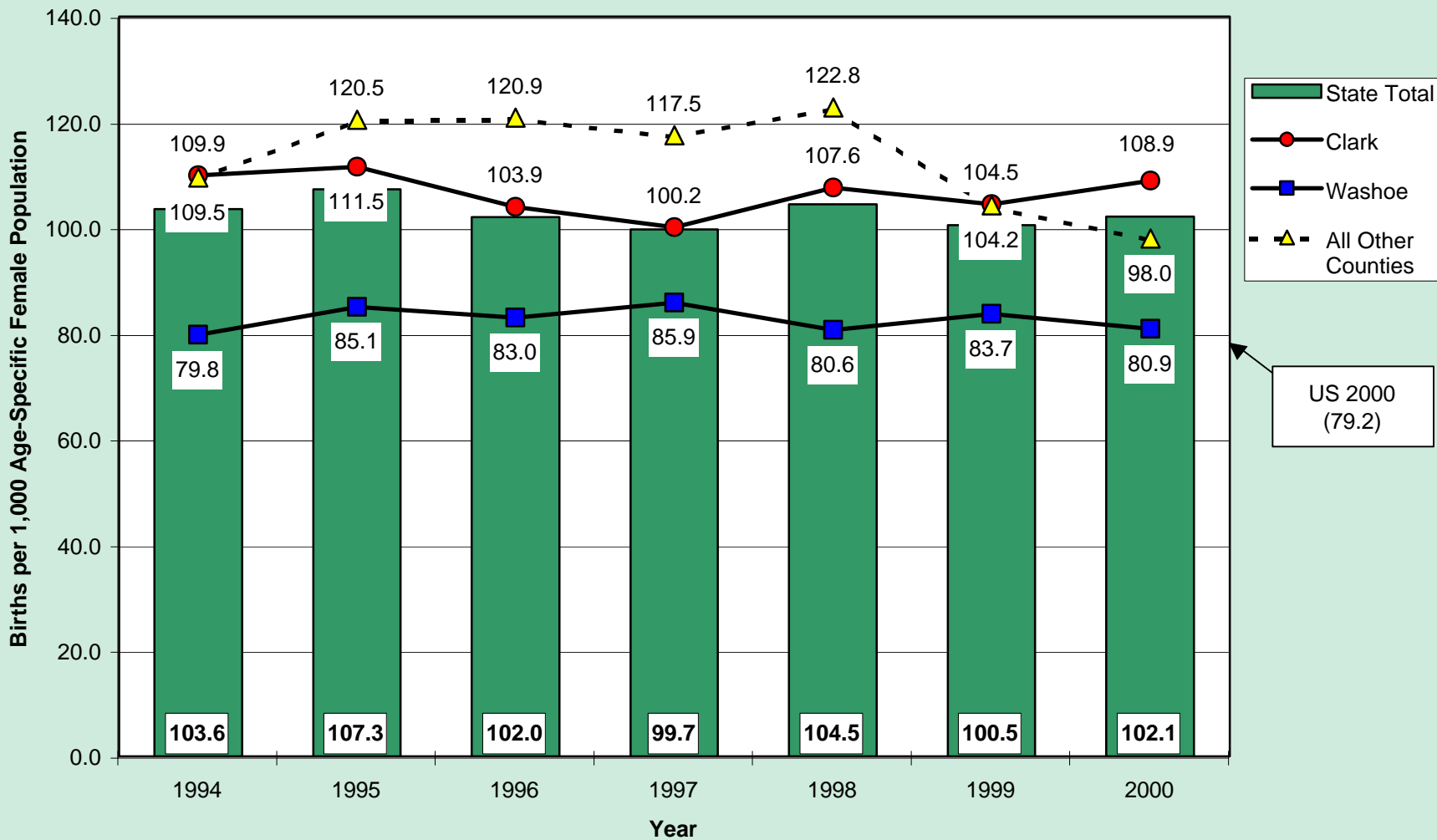
**Figure 17. Low Birth weight (<2,500g) Percent by Race/Ethnicity, Nevada Residents, 2000**

**Figure 20. Teen Birth (15-19 yrs) Rate by County/Region of Residence, Nevada, 1994-2000**

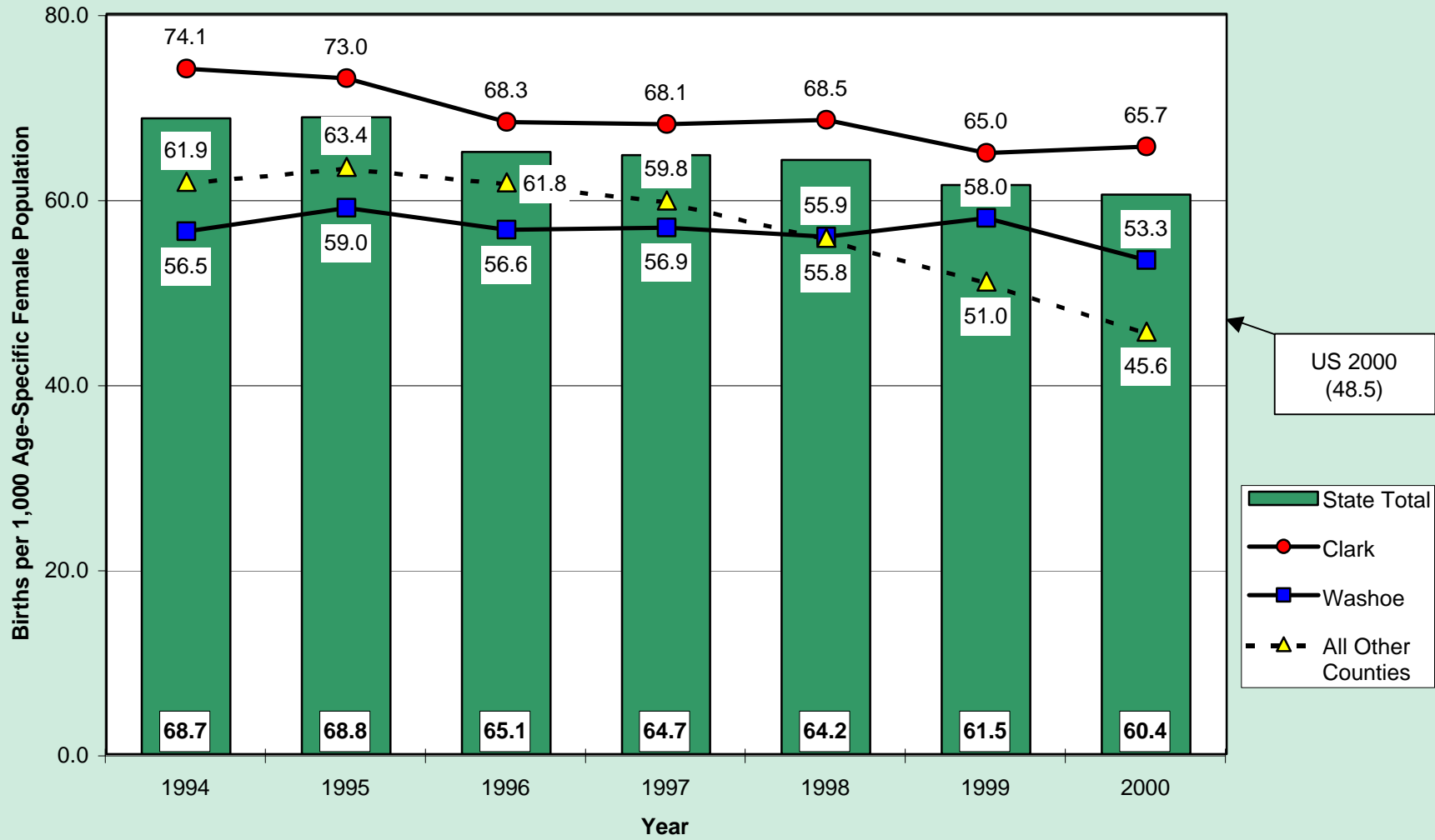


Figure 21. Teen Birth (15-17 yrs) Rate by Race/Ethnicity, Nevada, 2000

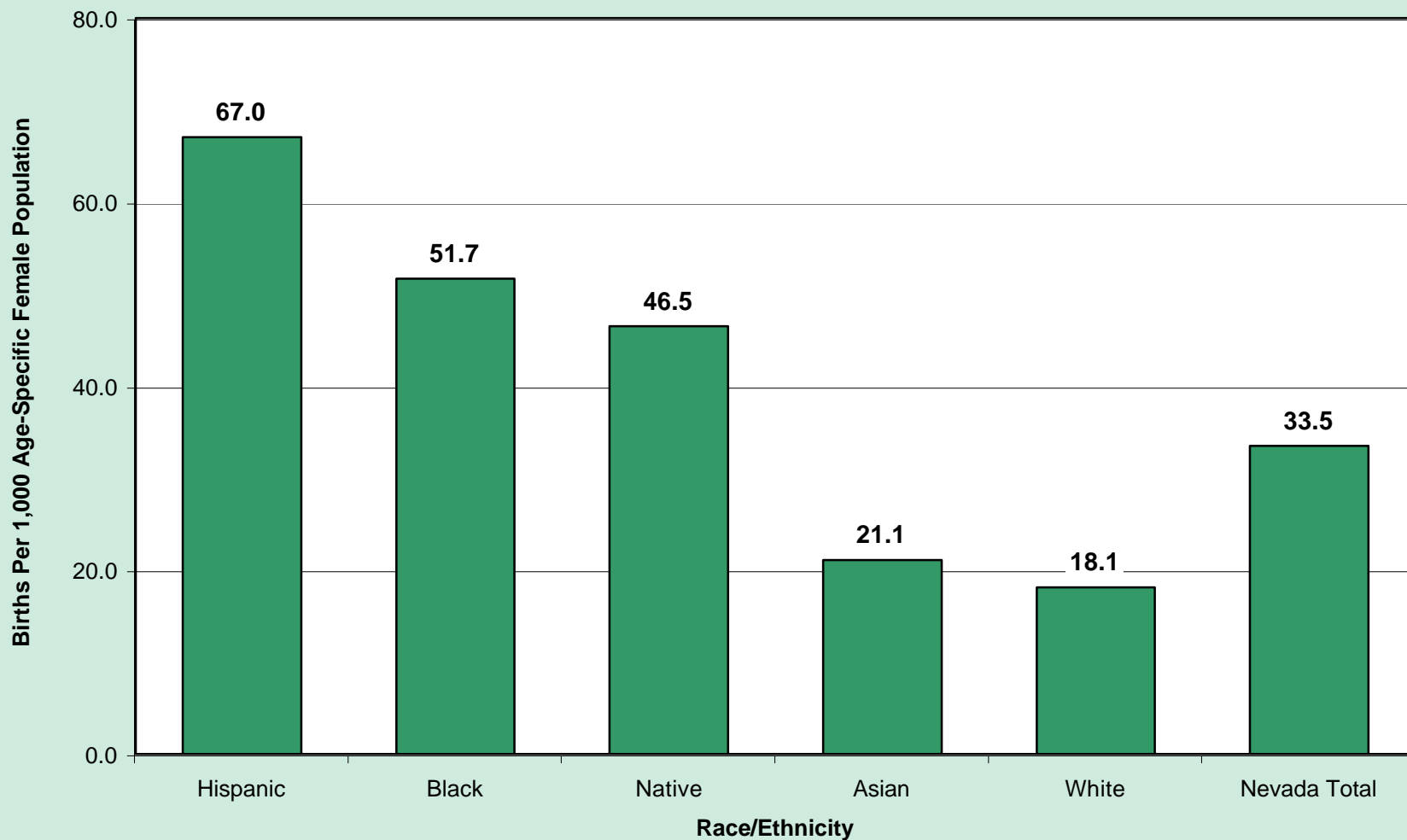


Figure 22. Teen Birth (18-19 yrs) Rate by Race/Ethnicity, Nevada, 2000

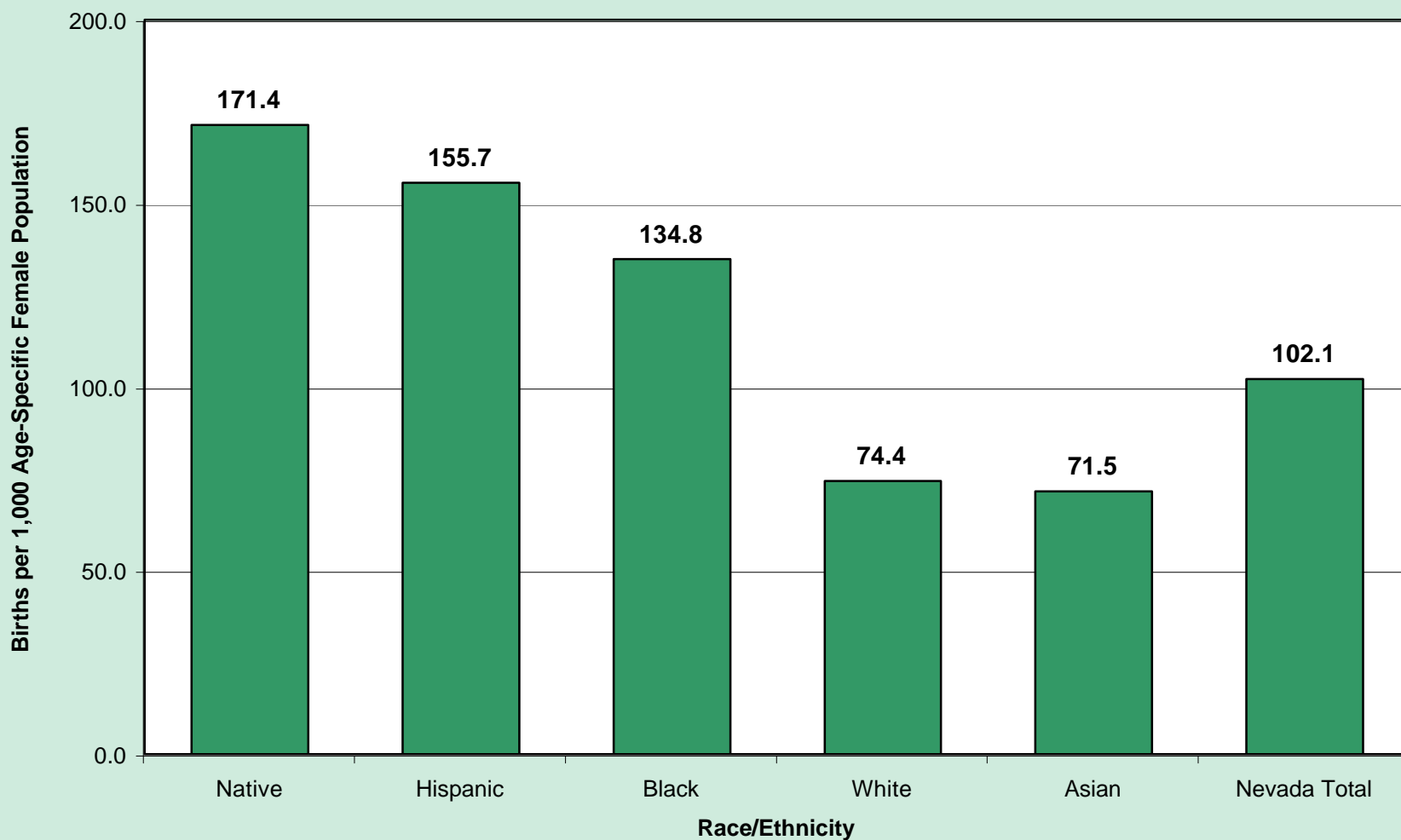
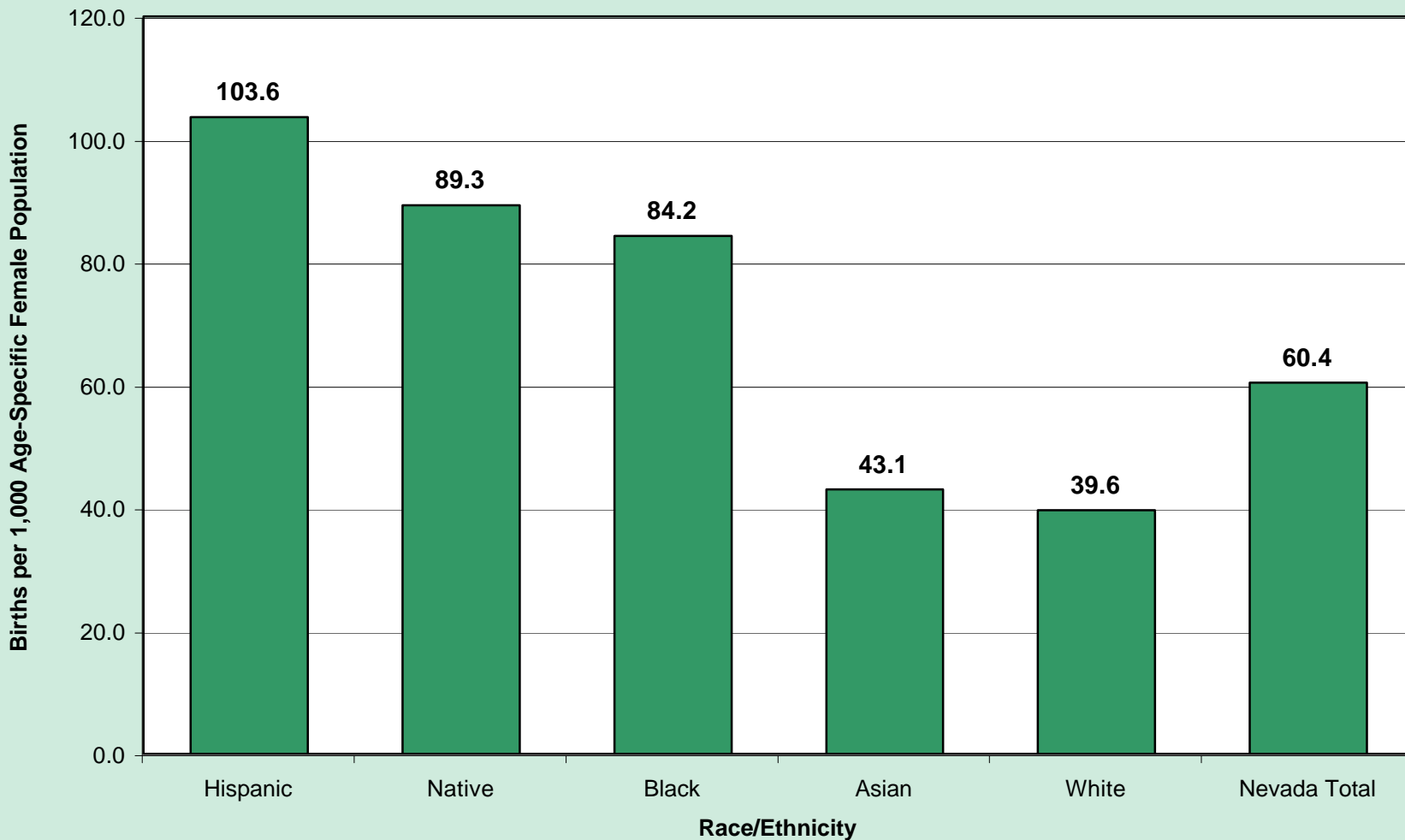


Figure 23. Teen Birth (15-19 yrs) Rate by Race/Ethnicity, Nevada, 2000

DIG1-5 are determinations of the numbers diagnosed with anomalies:

- DIG1 = 455 newborns with at least one anomaly;
- DIG2 = 151 newborns with at least two anomalies;
- DIG3 = 63 newborns with at least three anomalies;
- DIG4 = 35 newborns with at least four anomalies;
- DIG5 = 10 newborns with at least five anomalies;

This reflects 455 individuals diagnosed with anomalies, including 151 individuals with two or more anomalies.

*In 2000, Nevada's infant mortality rate was 6.5 per 1,000 live births, a decrease from Nevada's peak of the last five years of 6.9, per 1,000 births, in 1998. Washoe County (from 9.2 to 7.1) as a region, and Blacks (from 17.0 to 13.2) as a racial/ethnic group contributed to this improvement in the rate. However, they continued to have the highest rates in their respective categories. Hispanics followed Blacks at a rate of 6.73 per 1,000 live births, while Native Americans had the lowest rate at 5.3 per 1,000 live births.*

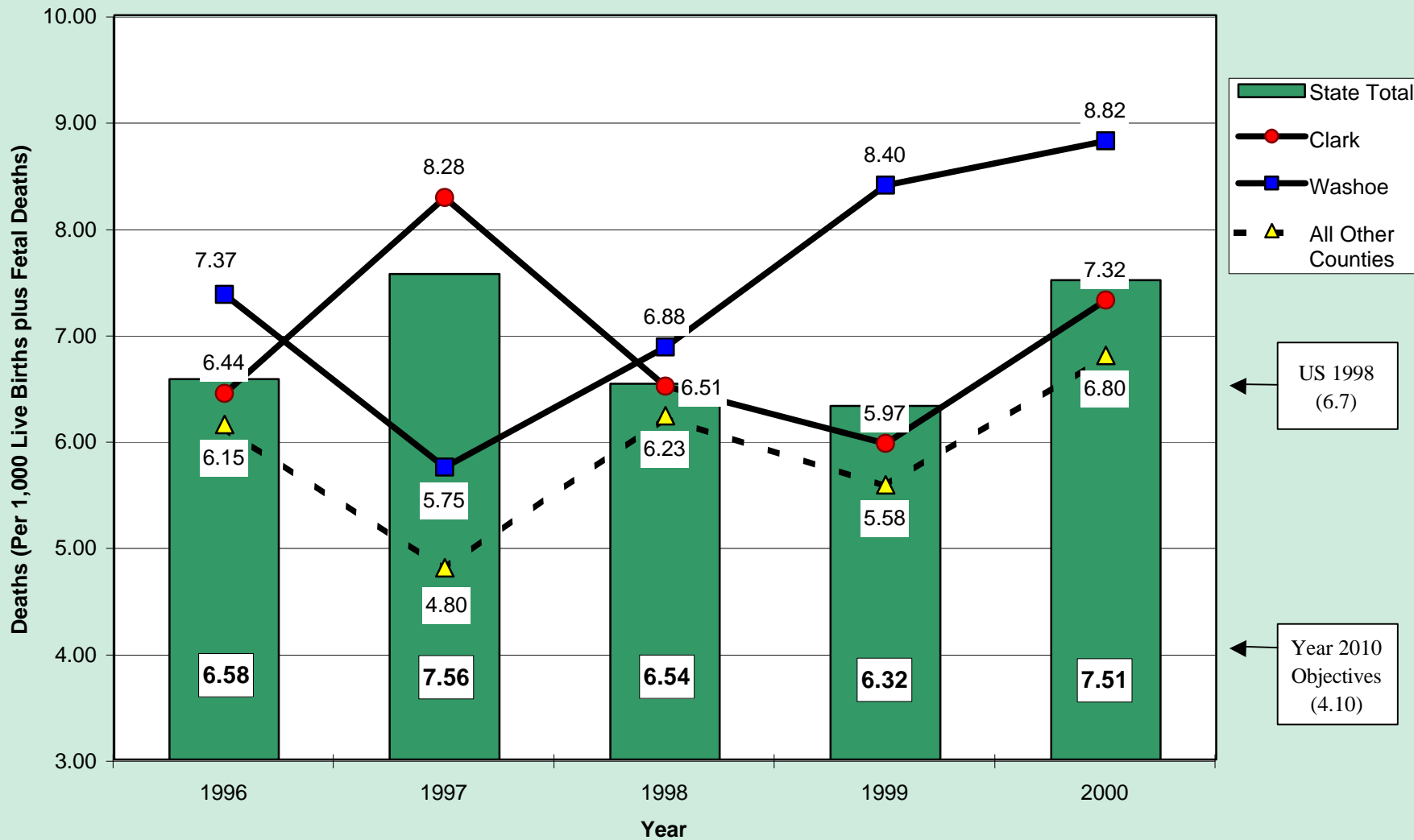
*Although the number of resident deaths increased 62.8% from 9,133 deaths in 1990 to 14,864 deaths in 2000; age-adjusted comparisons show that Nevada has experienced a 9.8% decrease in the overall mortality rate from 1990 (976.9) to 2000 (881.5 per 100,000 – 2000 US Standard population). People ages 65 and older represented 67.2% of all Nevada resident deaths in 2000.*

*Diseases of the Heart and Malignant Neoplasms (i.e. Cancers) ranked one (26.9%) and two (24.6%), respectively for the leading causes of death in Nevada. In 2000 these two diseases were responsible for 7,659 deaths in Nevada, accounting for 51.5% of total deaths in the State. Once age-adjustment comparisons were made, Nevada's Diseases of the Heart mortality rate (246.4) was lower than the national average (1999 - 267.8 per 100,000 – 2000 US Standard population), while Nevada's cancer rate (204.5) was slightly higher than the national average (1999 - 202.7 per 100,000 – 2000 US Standard population).*

*After age-adjustment, racial/ethnic group comparisons indicate that Whites had the highest death rate for Diseases of the Heart (256.8 per 100,000 – 2000 US Standard population), while Blacks had the highest death rate for Cancer (224.3 per 100,000 – 2000 US Standard population) in 2000.*

**Figure 28. Infant Mortality Rates, Nevada Residents, 1996-2000**

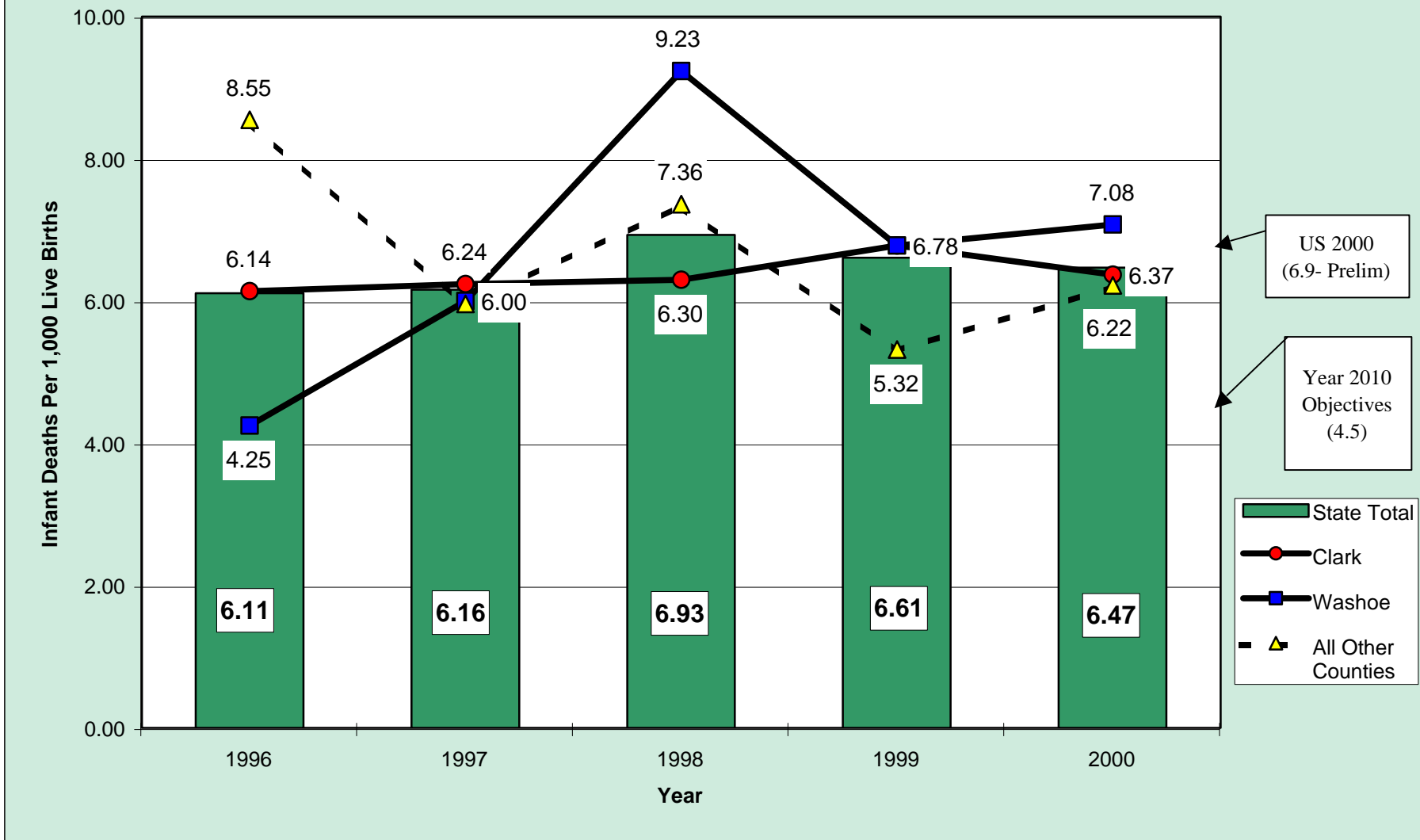


Figure 29. Infant Mortality by County/Region of Residence, Nevada, 2000

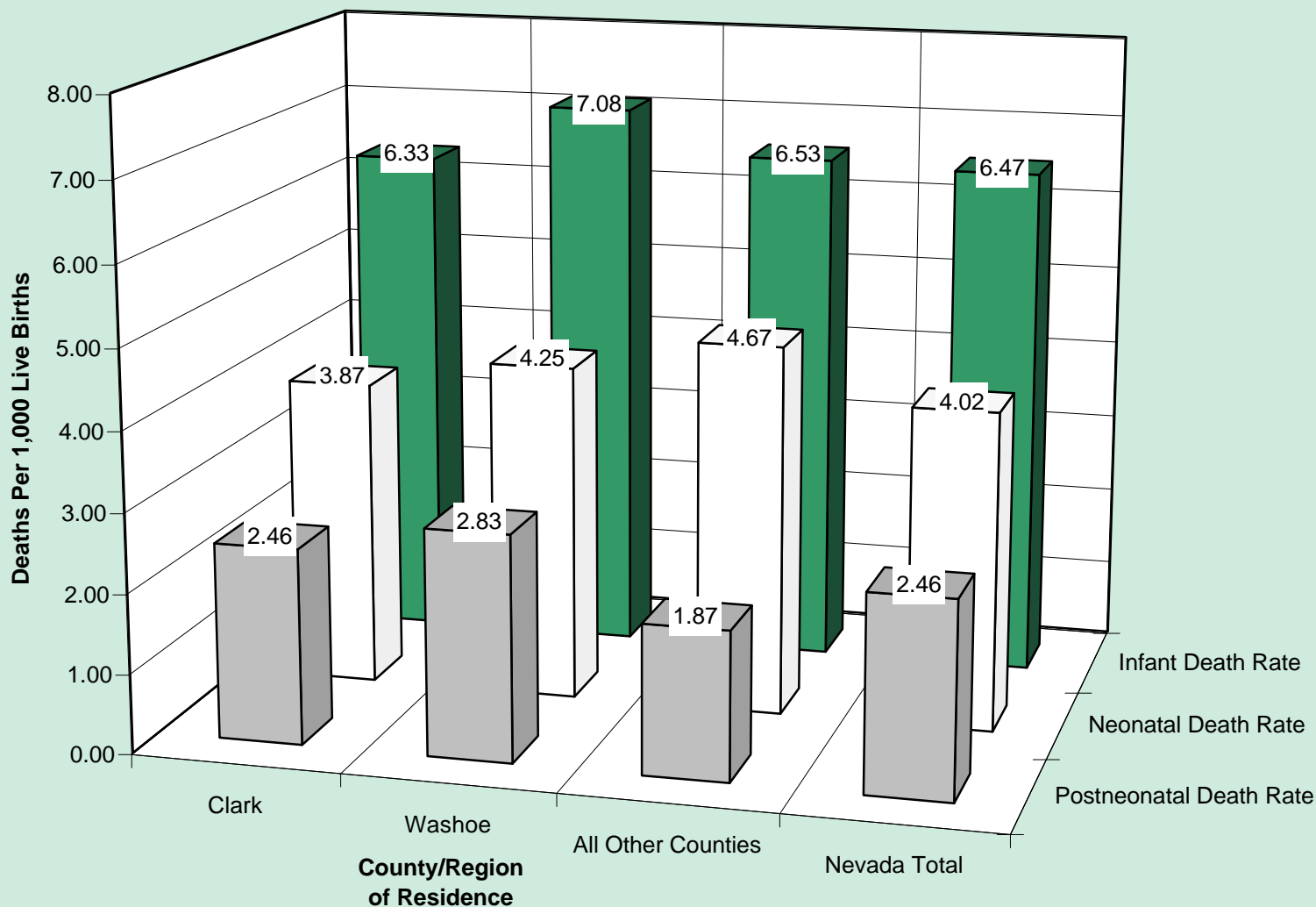
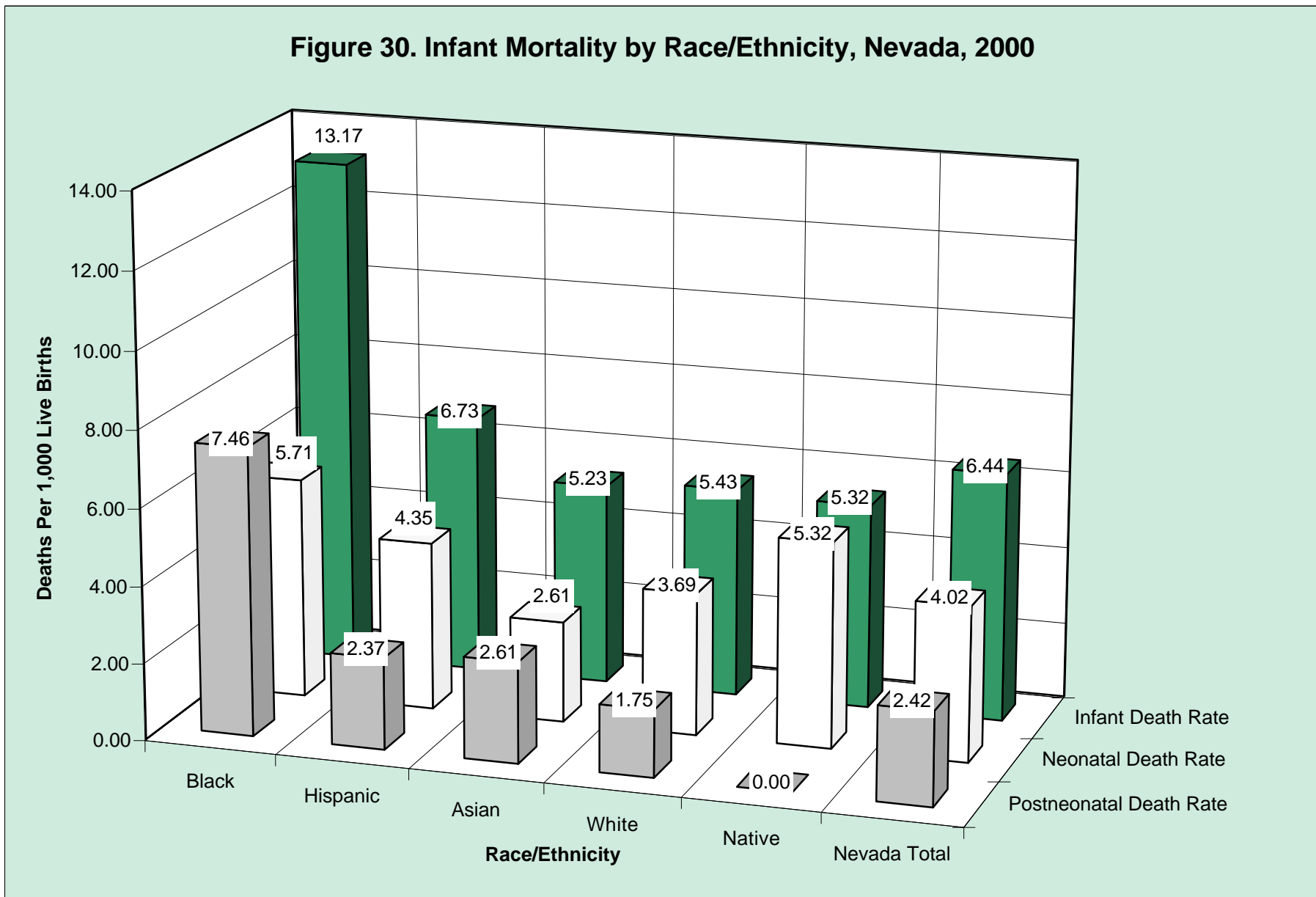
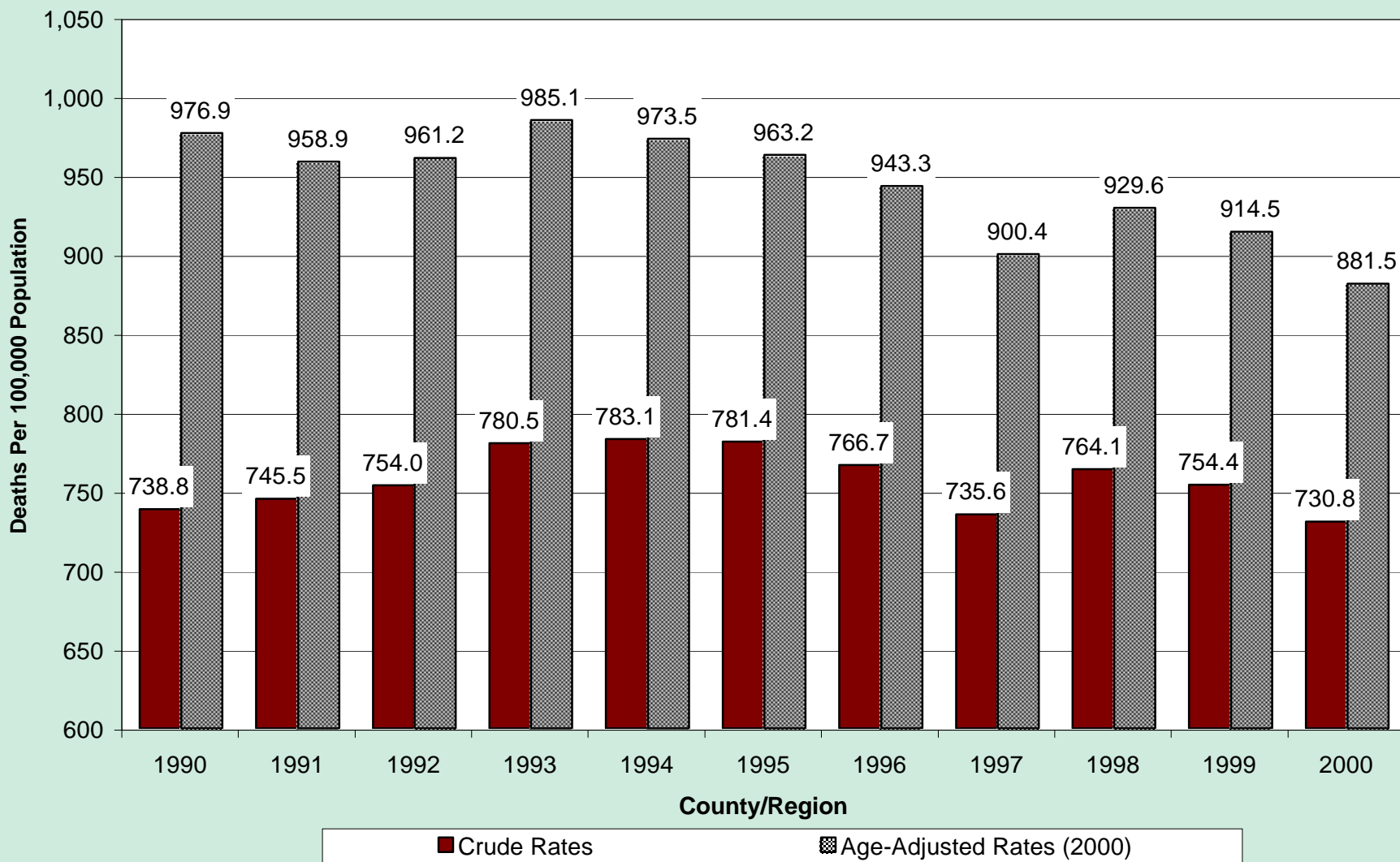


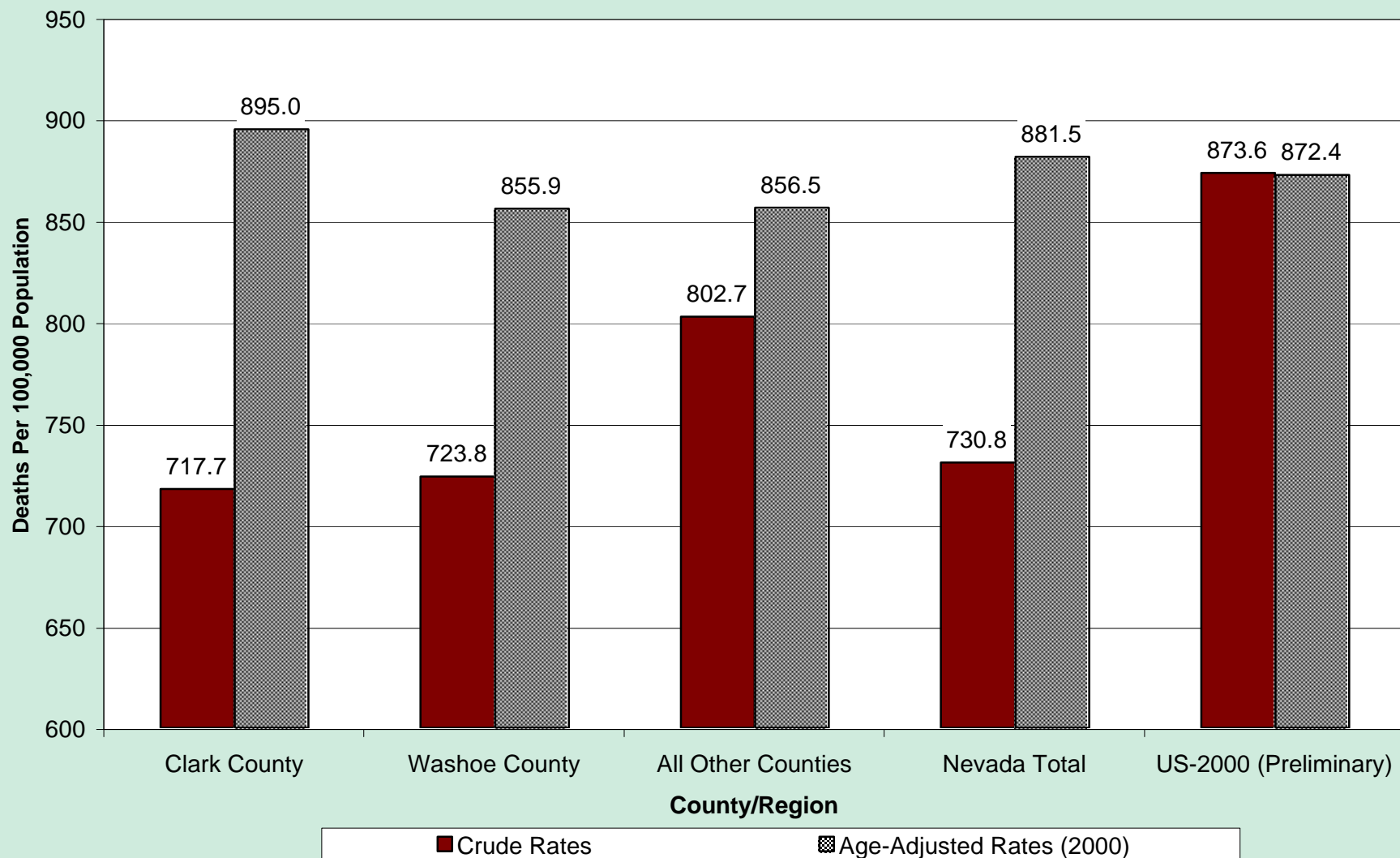
Figure 30. Infant Mortality by Race/Ethnicity, Nevada, 2000



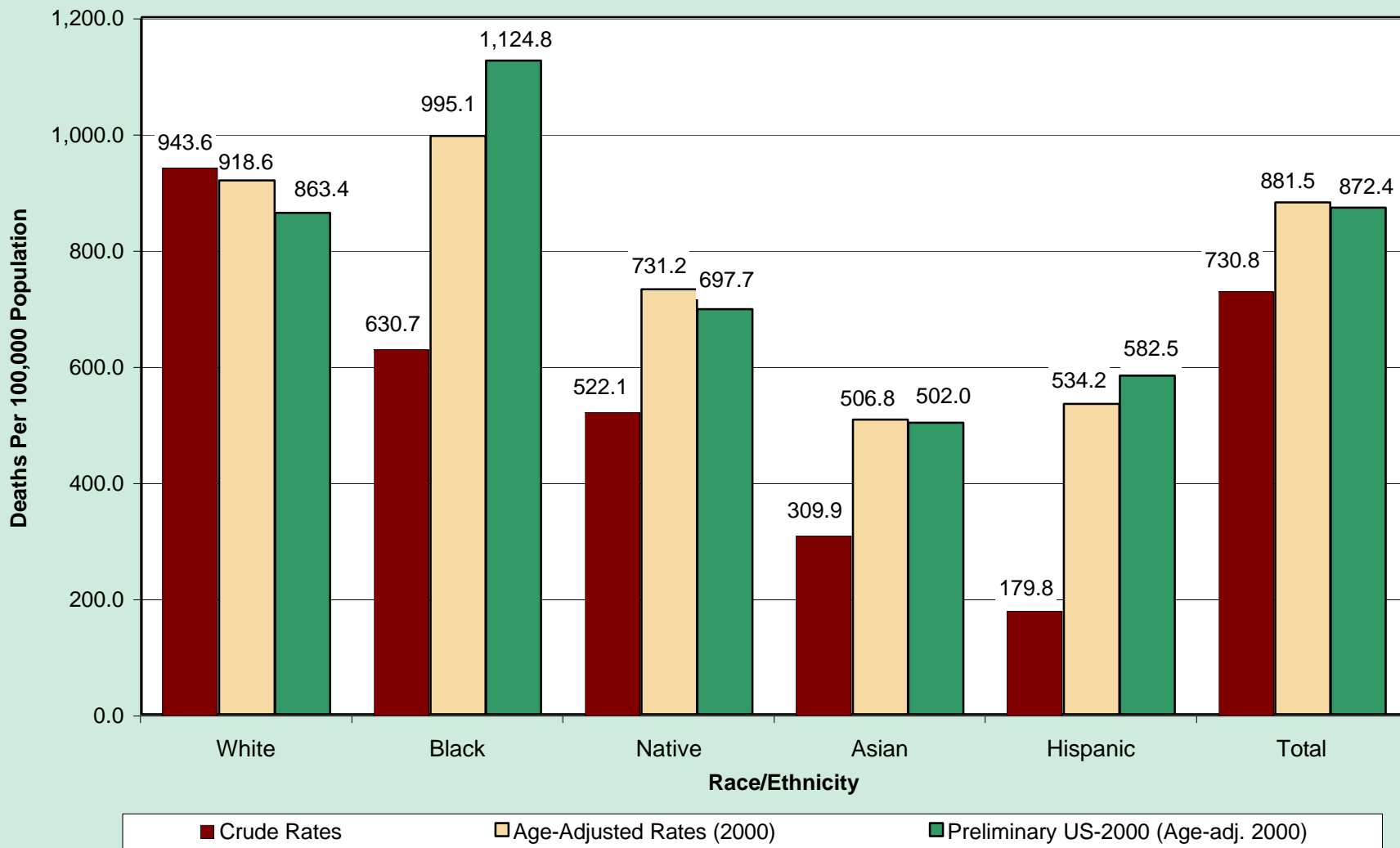
**Figure 31. Crude and Age-Adjusted (2000) Mortality Rates, Nevada Residents, 1990-2000**



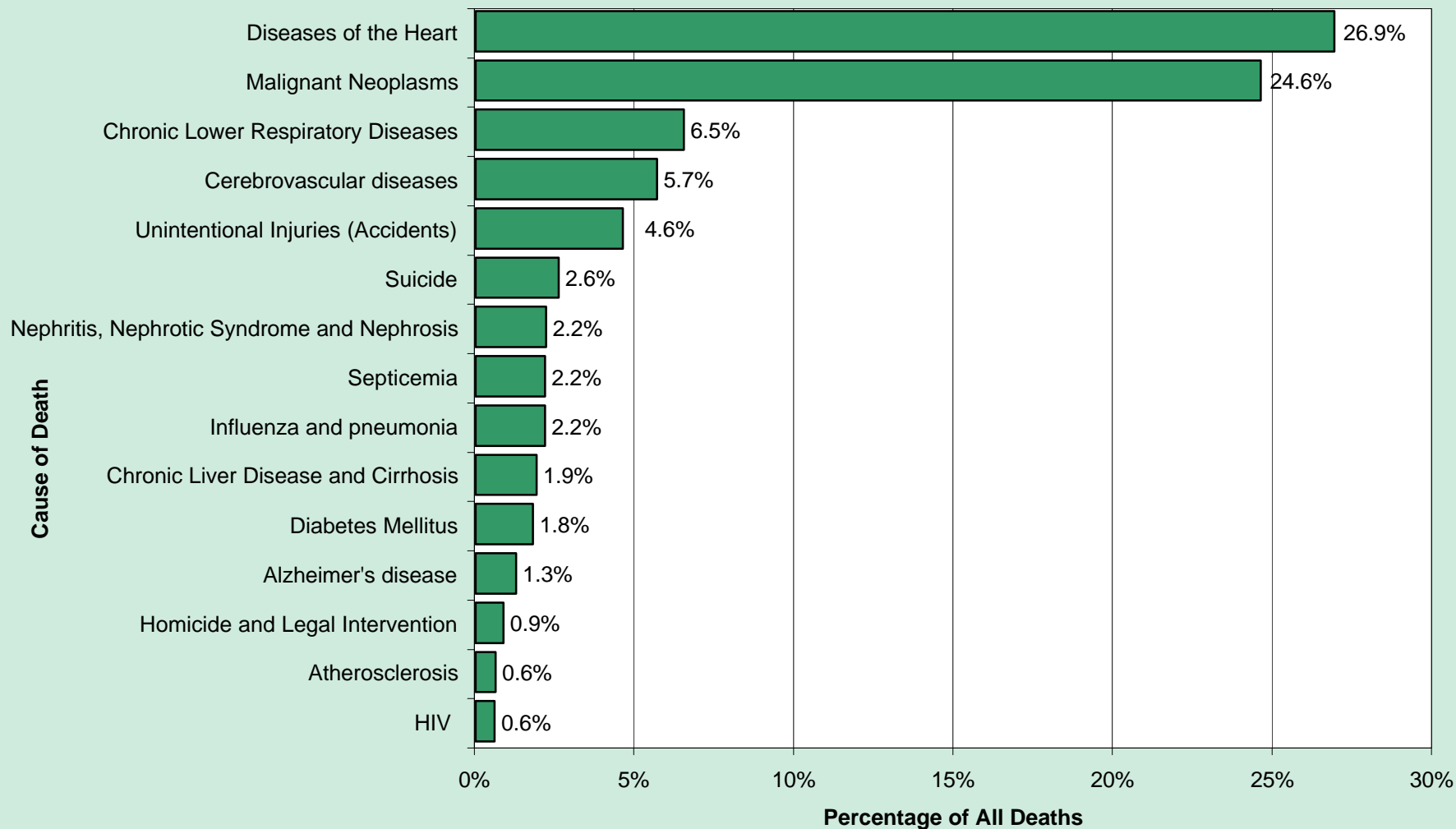
**Figure 32. Mortality Rates by County/Region of Residence, Nevada Residents, 2000**



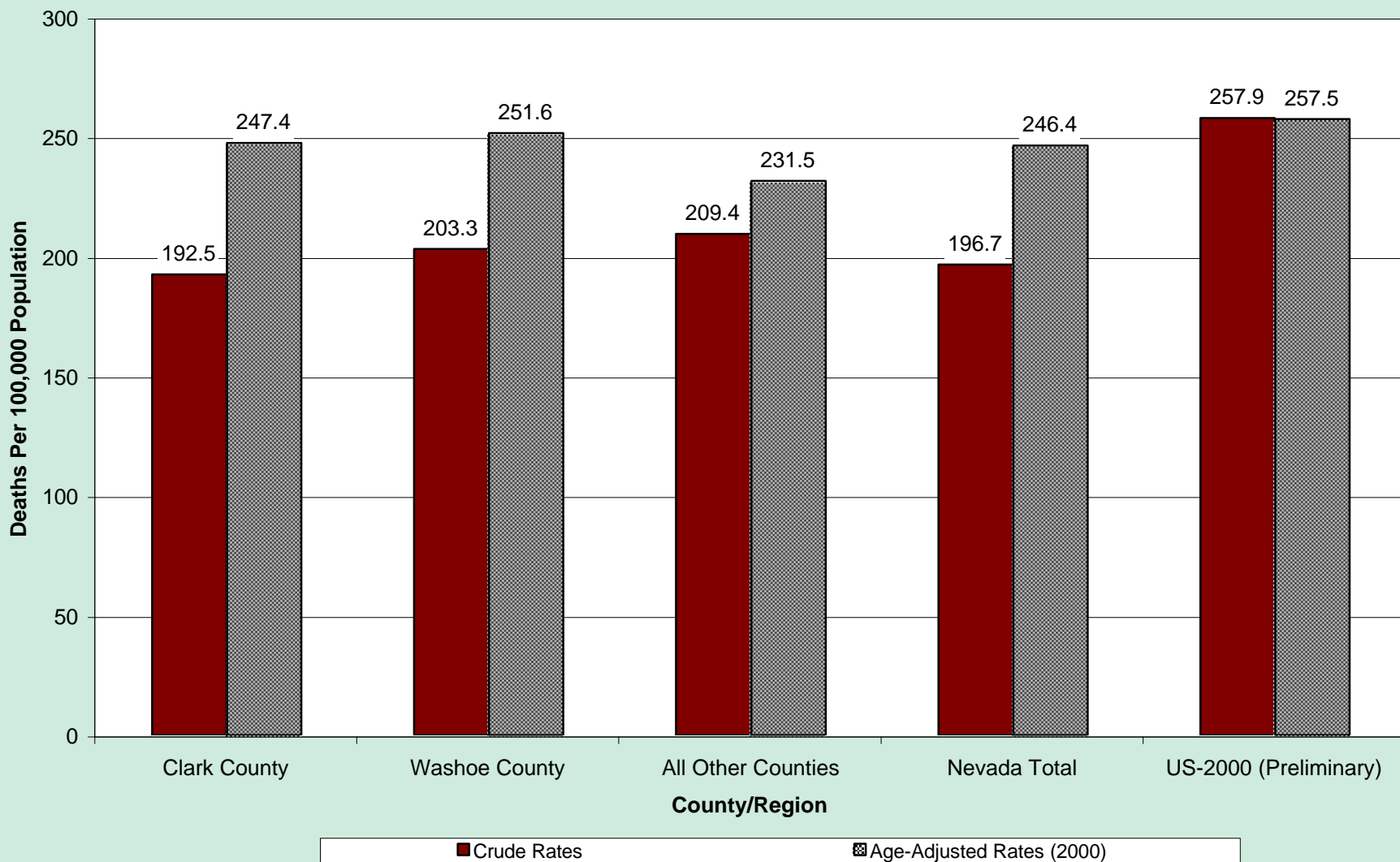
**Figure 33. Mortality Rates by Race/Ethnicity, Nevada Residents, 2000**



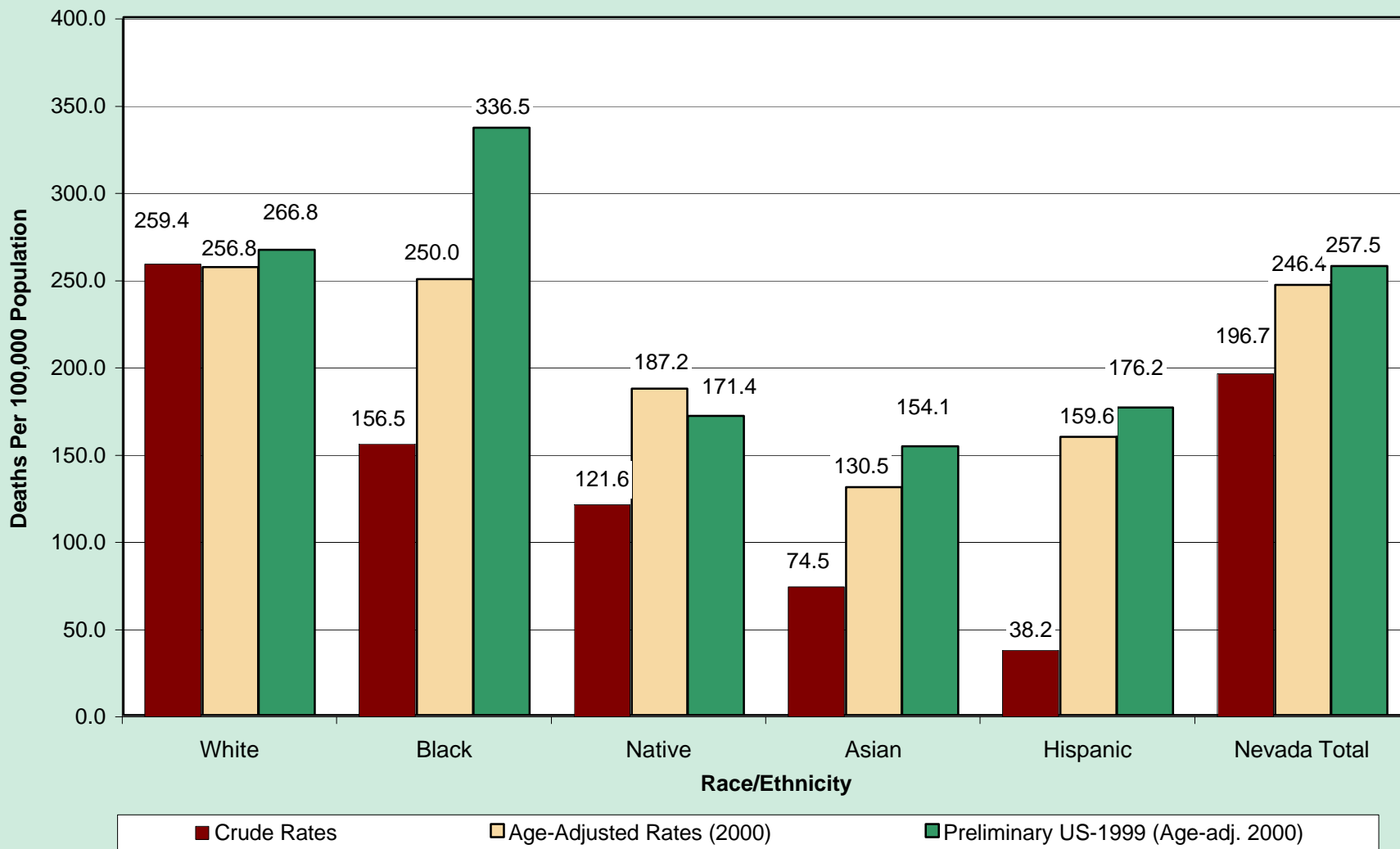
**Figure 34. Leading Causes of Death as a Percentage of All Deaths, Nevada Residents, 2000**



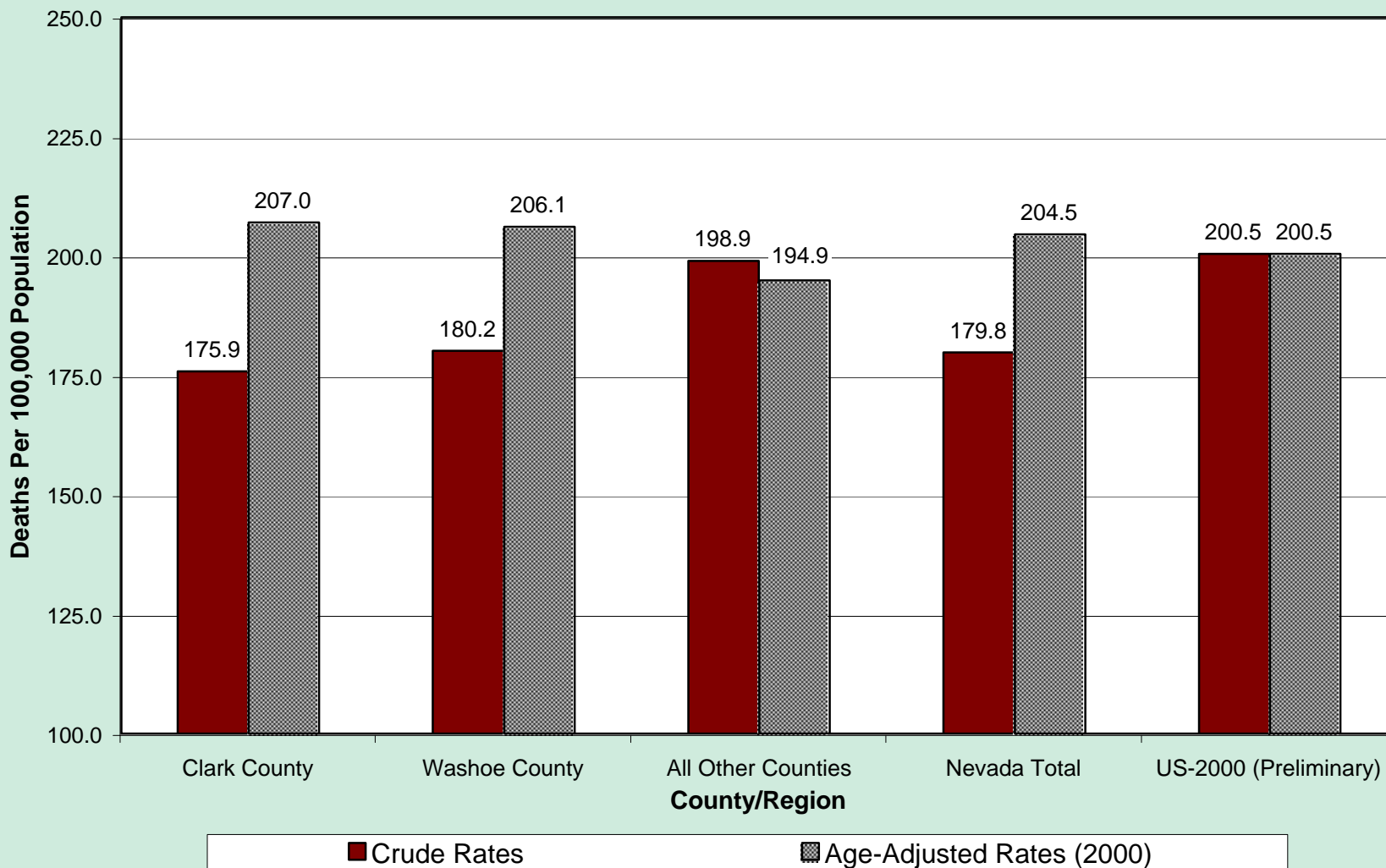
**Figure 35. Death Rates for Diseases of the Heart by County/Region of Residence, Nevada Residents, 2000**



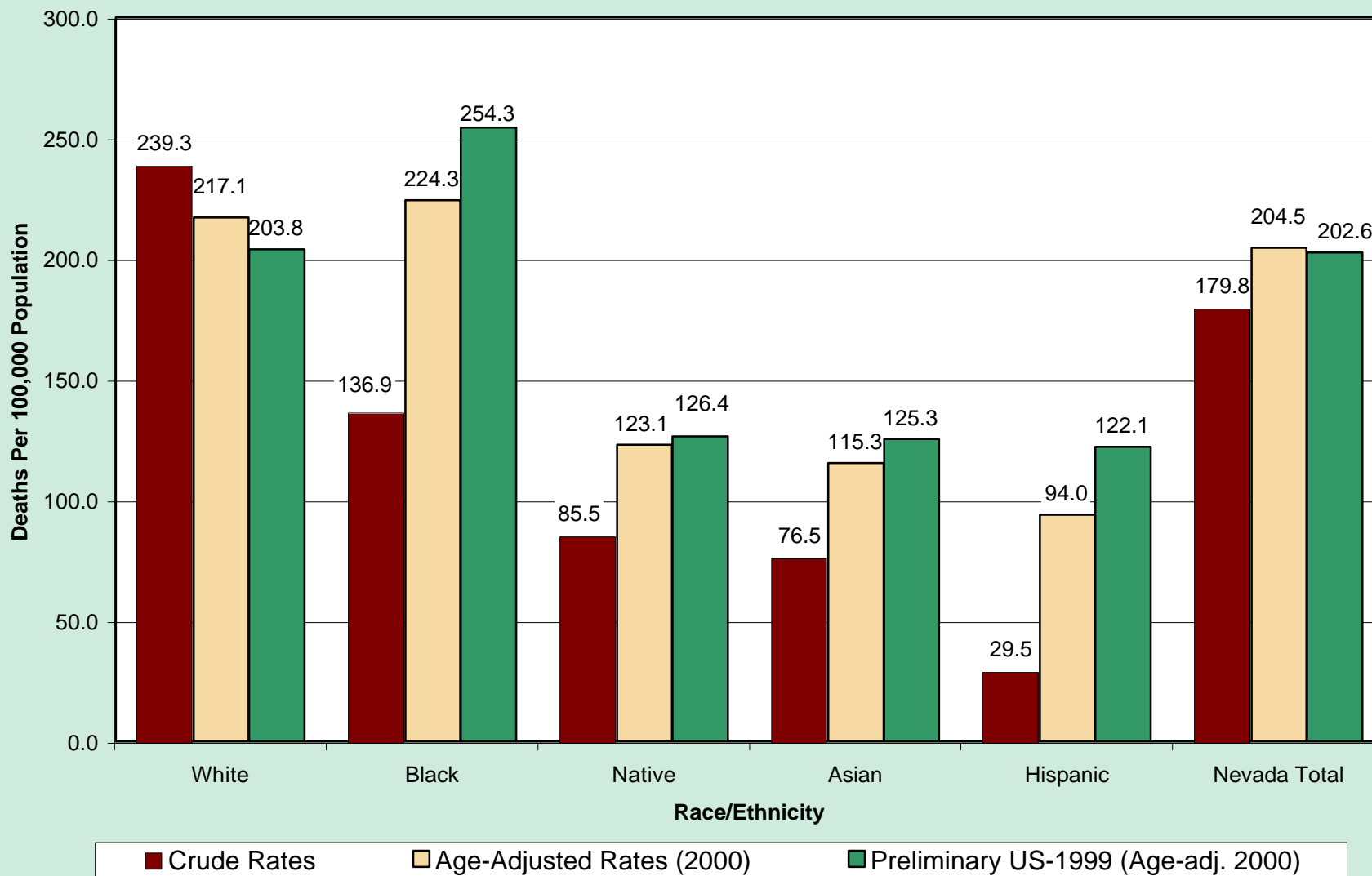
**Figure 36. Death Rates for Diseases of the Heart by Race/Ethnicity, Nevada Residents, 2000**

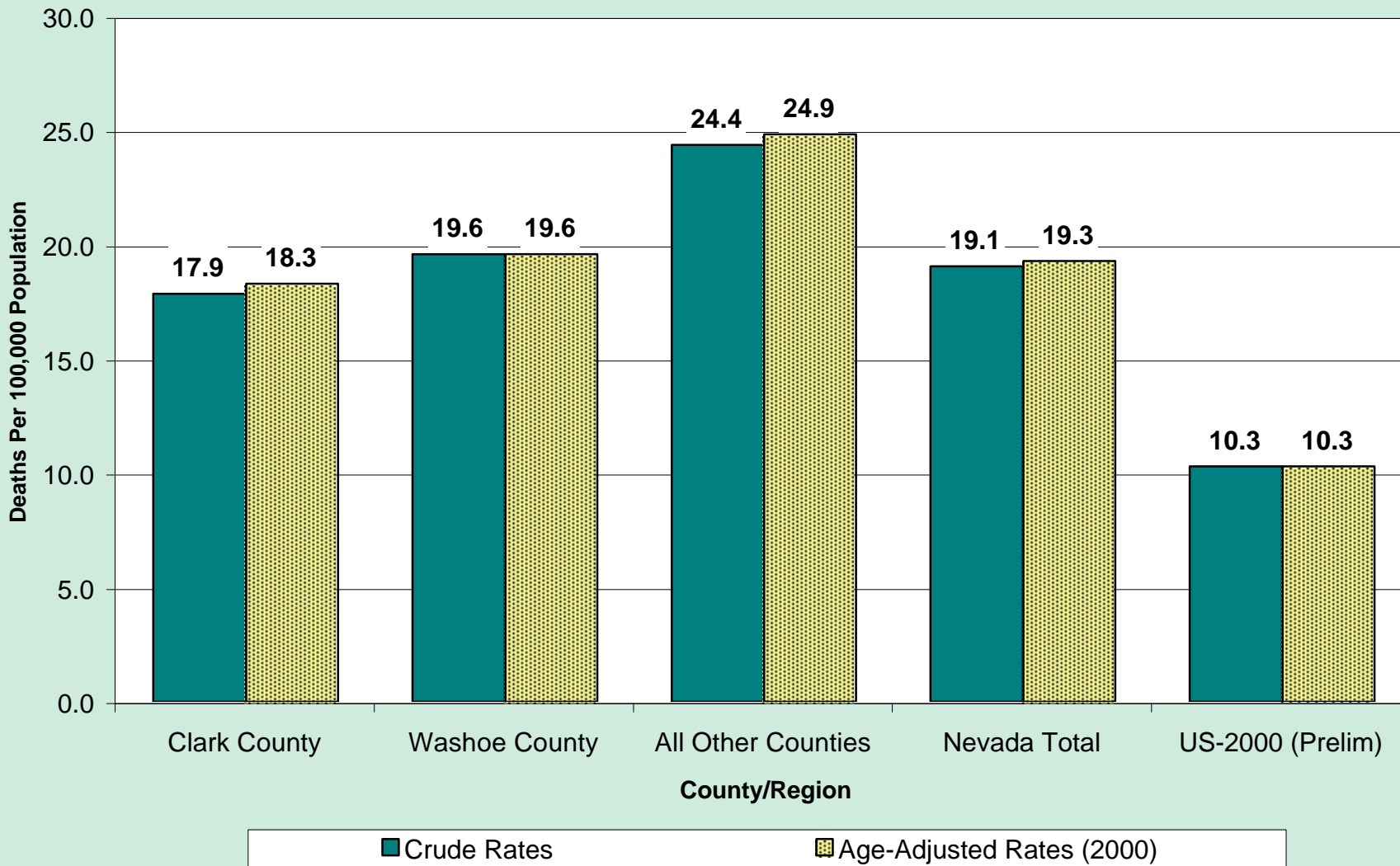
*In 2000, the age-adjusted Suicide death rate for Nevada residents (19.3) was almost twice the preliminary national average (10.3 per 100,000 – 2000 US Standard population). Nevada has continually ranked highest in the nation during the past 10 years for suicide deaths. Regional, race/ethnicity, and age analysis showed the highest suicide death rates were among All Other Counties, Whites, and the 45-54, 75-84 and the 85 and older age groups.*

*In 2000, the age-adjusted death rate for motor vehicle crashes for Nevada residents (13.2) was lower than the preliminary national average (15.2 per 100,000 – 2000 US Standard population). The highest groups for those dying in motor vehicle accidents were All Other Counties as a region, Native Americans and the 15-24 and 85 and older age groups.*

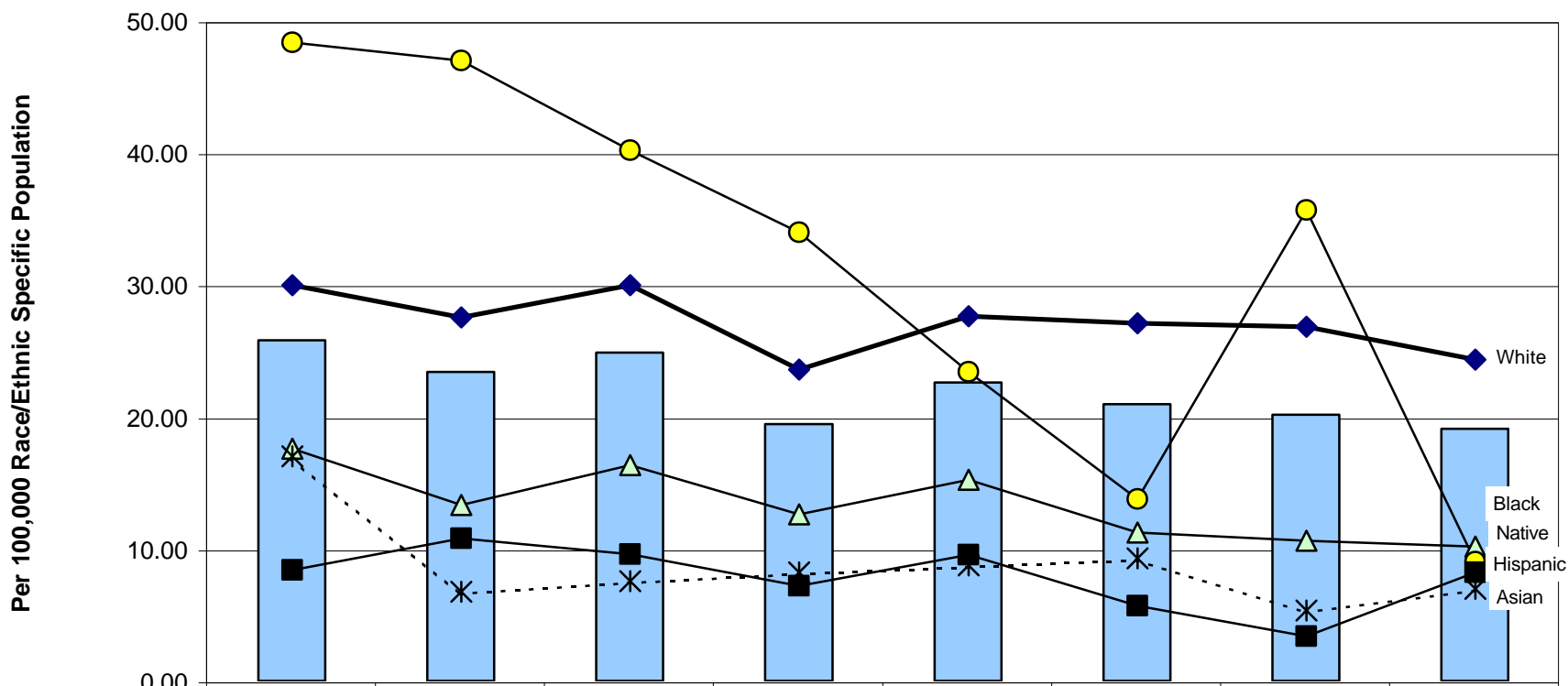
*Once Out of State Residents are included in the analysis, the same pattern as in previous years remains, in that Out of State Residents contributed significantly to the overall number of Suicides and Accidental Deaths in Nevada for 2000. Out of State Resident Suicides accounted for 9.8% of all Suicides in Nevada, while the percentage of total accidental deaths in Nevada attributed to Non-Nevada Residents was 19.9% in 2000. Out of State Resident deaths from Water, Air and Space, and Other Transport Accidents (54.2%) and Motor Vehicle Accidents (28.6%) were the leading subcategory percentages of the total number of accidental deaths in Nevada for 2000.*

**Figure 41. Suicide Mortality Rates by Race/Ethnicity, US (1999) and Nevada (2000)**

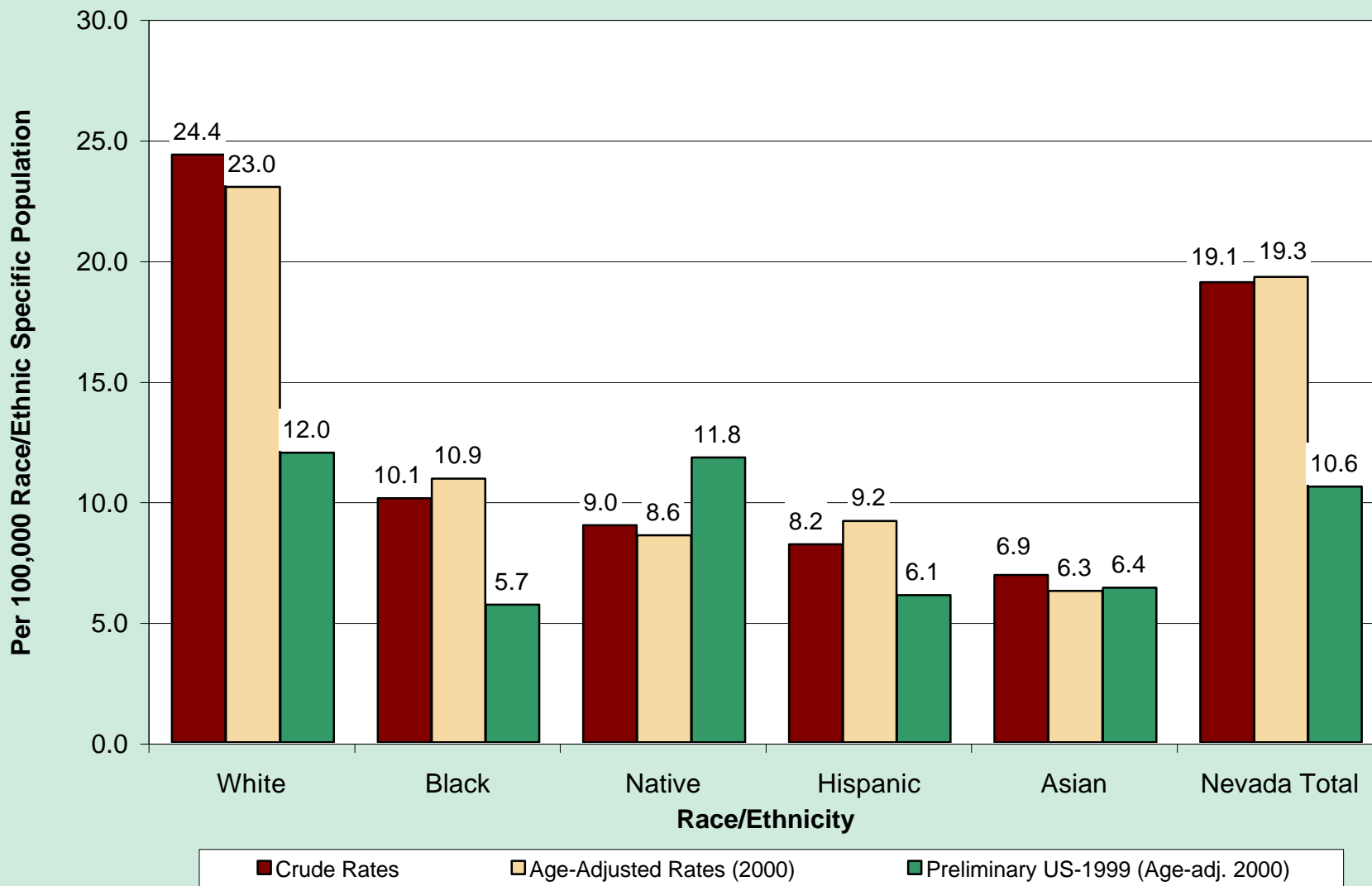
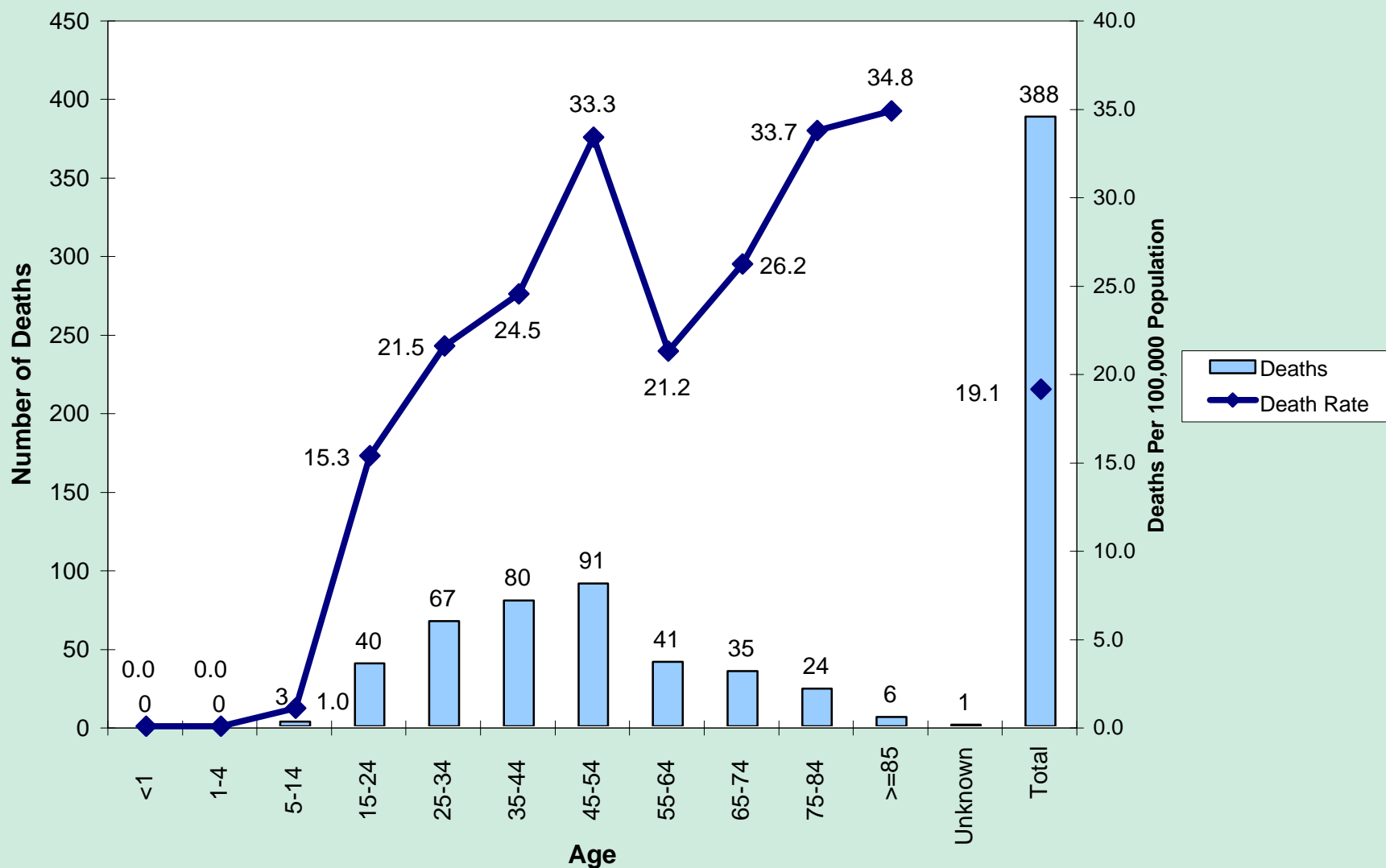
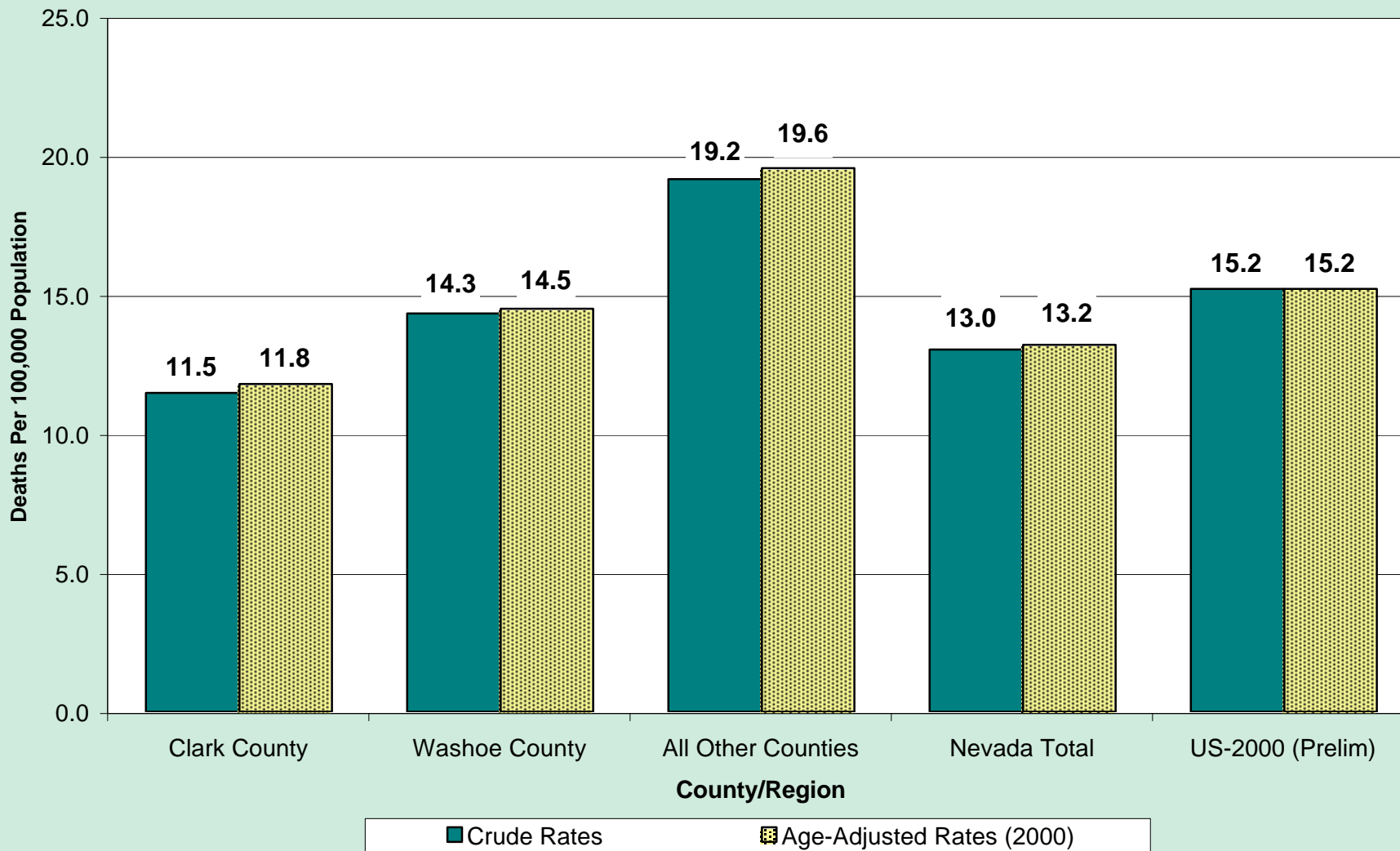


Figure 42. Suicide Deaths by Age, Nevada Residents, 2000

**Figure 44. Motor Vehicle Mortality Rates by Race/Ethnicity, US (1999) and Nevada (2000)**

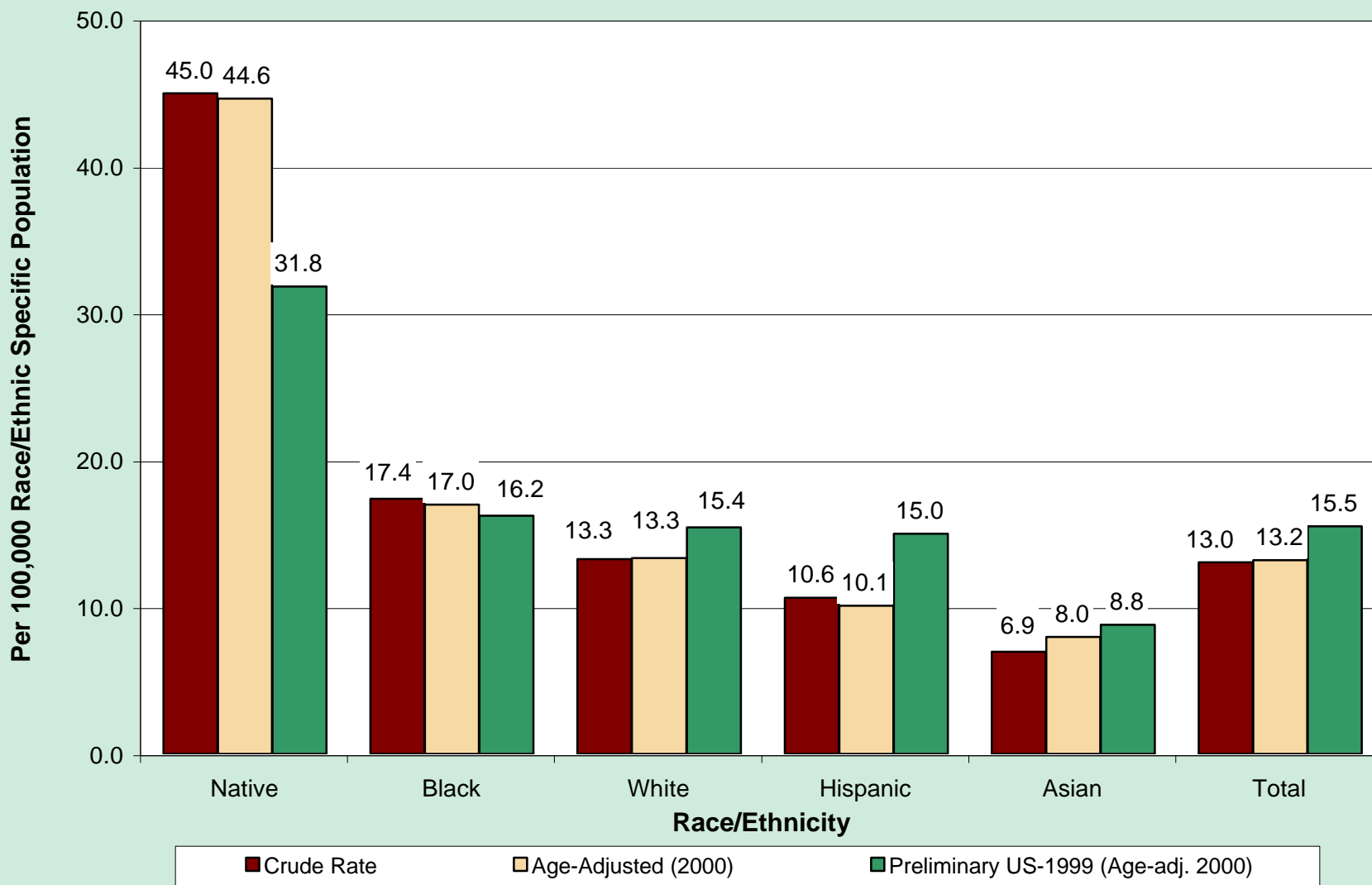
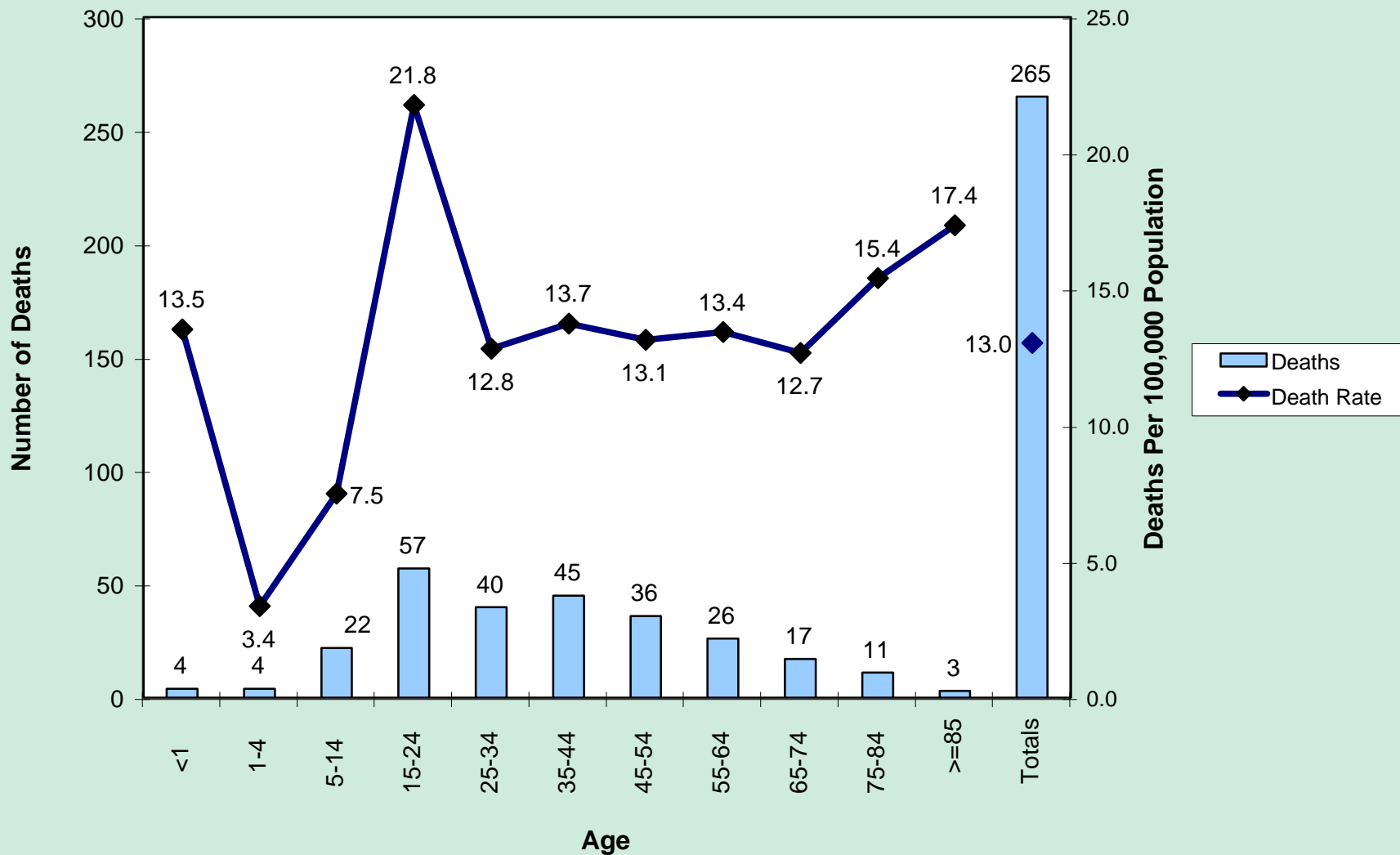


Figure 45. Motor Vehicle Crash Deaths by Age, Nevada Residents, 2000
